Company Highlights

Singapore Technologies Engineering Ltd announced that VT iDirect, Inc. acquired 100% of Parallel Limited for about S\$9m in cash. The purchase consideration was arrived at on a willing buyer willing seller basis, based on Parallel's unaudited net tangible assets as of 30 December 2009. VT iDirect, Inc. is a wholly owned subsidiary of Vision Technologies Systems, Inc., the US headquarters of ST Engineering.

CNA Group Ltd announced that it will purchase the remaining 49% stake of its Vietnam subsidiary, HTE Vietnam Co., Ltd. The strategic acquisition in HTE will be fulfilled by the issue of 12.3 million CNA ordinary shares at an issue price of S\$0.34 each. This constitutes about 6% of the enlarged CNA share capital of 202.1 million shares.

Hotel Properties Limited wishes to announce that its subsidiary company, Amberwood Investments Pte Ltd has acquired 49% of the total issued and paid-up capital of Straits Realty Co., Ltd for a consideration of THB8,085,000.00 (approximately S\$348,000). Straits Realty Co., Ltd is involved in properties and investments and its remaining 51% stake has been acquired by Astrid Holdings Co, Ltd.

Keppel Corporation Limited announced that Sino-Singapore Tianjin Eco-City Investment and Development Co., Ltd signed an RMB 13 billion agreement with Farglory Land Beijing, the largest Taiwanese developer. The parties will develop a gross floor area of 1.4 million square metre integrated eco community for nearly 13,000 households as well as a "play" hub for residents and visitors of the Tianjin Eco-City when fully completed in 2014.

Epure International Ltd has formally inked its first overseas contract in Saudi Arabia with Marafiq, a government-linked power and water utility provider. The contract amount has increased from the initial sum of RMB562 million to approximately RMB620 million due to an additional scope of work to modify, upgrade and refurbish an existing lagoon treatment system. The project is expected to be completed by 2011.

Eu Yan Sang International Ltd announced that Mr Robert James Eu Yee Sang will replace Dr Jennifer Lee Gek Choo as its non-executive chairman of the board of directors with effect from 1 January 2010. Dr Jennifer Lee Gek Choo has been appointed as the lead independent director of the Company and will remain as the chairman of the compensation committee and a member of the audit, nominating and strategic direction committees.

China Auto Corporation Ltd announced that it had through its two subsidiary companies sold 64.697 million shares respectively in the issued and paid up capital of its associated company, Creative Master Bermuda Limited, at a price of S\$0.08 per share and gross consideration of S\$5,175,760. Prior to the Share Sale, the Company and its subsidiaries held approximately 25.3% of the issued share capital of CMBL. The Group shall cease to have any beneficial shareholding interest in CMBL with effect from 31 December 2009.

Broadway Industrial Group Limited wishes to announce that it has increased its investment in wholly-owned subsidiary, Ningbo Broadway Plastic Packaging Co Ltd by USD1.32 million. The Company's wholly owned subsidiary, Compart Asia Pte Ltd, has also increased its investment in subsidiaries, Compart Precision (Shenzhen) Co Ltd and Compart Hi-Precision Technologies (Shenzhen) Co Ltd by USD2.85 million and USD4.3 million respectively.



Kim Eng Holdings Limited wishes to advise that its wholly owned subsidiary, KE Strategic Pte Ltd has agreed to terminate its joint venture agreement pertaining to Emfore Capital Partners Pte. Ltd. KE Strategic will transfer its entire 51% equity stake in Emfore to the other existing shareholders of Emfore. Kim Eng Investment Limited will divest its entire investment of US\$1.2 million comprising 12 Investment Units, each of which is for an amount of US\$100,000.00. As a result of the disposal, Emfore will cease to be a subsidiary of the Company.

Thomson Medical Centre Limited is pleased to announce that the Company has entered into a Joint Venture Agreement with Dr Ang Poon Liat and Dr Ang Ai Tin on 1 January 2010 to establish a joint venture. The joint venture will provide paediatric services specializing in the management of children's health. Thomson Medical will hold 80% and Dr Ang Poon Liat and Dr Ang Ai Tin each holding 10% of the shares of the joint venture.

Local and Regional Markets Headline

Singapore shares rose 0.62 per cent on Thursday in a shortened trading session on New Year's eve. The key Straits Times Index added 17.86 points to 2,897.62. In the broader market, gainers beat losers 1.6 to 1 in a volume of 1.15 billion shares valued at S\$1.27 billion.

Malaysian shares finished on Thursday with the key FTSE-Bursa Malaysia Kuala Lumpur Composite Index up 1.66 points or 0.13 per cent at 1,272.78. In the broader market, gainers beat losers 1.5 to 1 in a volume of 6 million lots valued at RM842.72 million (US\$245.91 million).

Hong Kong shares closed up 1.75 per cent on Thursday in the final trading session of 2009, with the benchmark Hang Seng Index up 375.88 points, or 1.75 per cent, to close at 21,872.50. Turnover in the half-day trading session totaled HK\$30.05 billion (US\$3.87 billion).

Japanese financial markets were closed on Thursday and Friday for the New Year's holiday period. Trading resumes on Monday, Jan 4, 2010.

US Market News

For Thursday's session alone, U.S. stocks declined, with a late-day sell-off pushing all three major indexes down about 1 percent as investors sold some of the year's best-performing stocks to lock in some of 2009's substantial gains.

After a fast sell-off late in the session, the Dow Jones industrial average ended down 120.46 points, or 1.14 percent, at 10,428.05. The Standard & Poor's 500 Index slid 11.32 points, or 1.00 percent, at 1,115.10. The Nasdaq Composite Index lost 22.13 points, or 0.97 percent, to close at 2,269.15. U.S. financial markets were closed on Friday for New Year's Day.

Volume was light, with many investors out for the holidays. Just 679.9 million shares traded on the NYSE, well below last year's daily closing average of 1.49 billion. On Nasdaq, about 1.27 billion shares traded, also sharply below last year's daily average of 2.28 billion.

Declining stocks outnumbered advancing ones on the NYSE by a ratio of 2 to 1, while on the Nasdaq, about 17 stocks fell for every 10 that rose.
