Company Highlights

- **Yanlord Land Group Ltd** announced that it has launched a concurrent offering of 120 million ordinary shares at S\$2.08 per share and S\$275 million convertible bonds at a conversion price of S\$2.6208 per share. The proceeds will be used to finance new investments and for general corporate and working capital purposes.
- **Yongnam Holdings Ltd** announced that it has secured two new contracts worth S\$40.7 million from Marina Bay Sands Integrated Resort and the Marina Coastal Expressway. It also informed that its Finance Director and Executive Director Mr Chia Sin Cheng is assisting the Commercial Affairs Department in its investigation on possible infringement of section 218 of the Securities and Futures Act.
- **ST Engineering Ltd** announced that its electronics arm, ST Electronics, has won a contract from the Infocomm Development Authority to create and operate the first Virtual World for the Singapore 2010 Youth Olympic Games.

Local and Regional Markets Headline

Singapore shares fell for the sixth straight trading day on Thursday, closing 1.51 per cent lower as traders looked for fresh leads in a lacklustre market, dealers said. The bluechip Straits Times Index tumbled 34.25 points to 2,237.20 on volume of 1.68 billion shares worth \$1.59 billion (US\$1.09 billion). Losers led gainers 363 to 129, with 782 issues unchanged.

Malaysian shares closed down 1.56 per cent on Thursday due to selling in selected blue chips by local funds, dealers said. Dealers said programme selling by local funds kept blue chips and index-linked issues in negative territory, adding that property, construction and finance stocks led the decline. The Kuala Lumpur Composite Index lost 16.49 points to 1,054.41. Losers outnumbered gainers 723 to 90. Trading posted moderate volume of 1.73 billion shares worth RM1.62 billion (US\$463 million).

Hong Kong share prices closed 1.70 per cent lower on Thursday, as falls in financial firms extended the market's recent correction, dealers said. The benchmark Hang Seng Index closed down 307.94 points at 17,776.66, its fourth consecutive drop. Turnover was HK\$63.64 billion (US\$8.16 billion).

The Nikkei average fell 1.4 per cent on Thursday, pulling away from last week's eight-month high, as banks such as Mizuho Financial Group tracked their US peers lower, while exporters like Honda Motor Co fell due to a strong yen versus the dollar. The benchmark Nikkei lost 137.13 points to 9,703.72. The broader Topix fell 1.3 per cent to 911.21.

The Dow and S&P 500 gained on Thursday, breaking a three-day losing streak, as data on the job market and regional manufacturing revived hopes that the recession-hit economy is stabilizing.

The Dow Jones industrial average rose 58.42 points, or 0.69 percent, to 8,555.60. The Standard & Poor's 500 Index gained 7.66 points, or 0.84 percent, to 918.37. The Nasdaq Composite Index was off just 0.34 of a point, or 0.02 percent, at 1,807.72.
