Company Highlights

- C.K. Tang Ltd is convening an Extraordinary General Meeting (the "EGM") scheduled to be held on 17 July 2009 to seek the approval of the shareholders of the Company ("Shareholders") for the voluntary delisting of CKT
- Wilmar International Limited wishes to announce the establishment of eight ship-owning and chartering companies (Singapore Subsidiaries). Wilmar has, through its 70% owned subsidiary Wilmar Oleo Pte. Ltd. incorporated a joint venture company in Italy known as "Oxem Oleo S.r.I." ("Oxem Oleo"). Oxem Oleo will engage in the sourcing, blending, sale and distribution of blended biodiesel products.
- New Toyo International Holdings Ltd announces that its wholly-owned subsidiary, New Toyo Aluminium PapervProduct Co. (Pte) Ltd had on 24 June 2009 entered into a share purchase agreement with another subsidiary, Tien Wah Press Holdings Berhad in relation to a proposed sale of the entire equity interest in Toyo (Viet) Paper Product Co., Ltd
- ST Engineering announced that its aerospace arm, ST Aerospace, has been appointed by Cimber Sterling A/S to support its fleet of five Boeing 737 next generation aircraft with options for additional aircraft over the next year. The contract, valued at €9m (about S\$18m), commences in June 2009 and involves a five-year Maintenance-By-the-Hour (MBHTM) component support programme that includes access to a stock of rotables on an exchange basis in support of Cimber Sterling's fleet.
- Pacific Healthcare Holdings Ltd. wishes to announce that as part of its internal streamlining exercise, it will be submitting its associate company, Haach Pacific Lifestyle & Wellness Pte Ltd ("Haach-Pacific") for voluntary liquidation. Haach-Pacific has been inactive since 2006.
- Midas Holdings Ltd announce today that its Aluminium Alloy Division, Jilin Midas Aluminium Industries Co., Ltd has secured a contract worth RMB70 million, to supply aluminium alloy extrusion profiles for a total of 30 train sets (1 train set = 8 train cars), an equivalent of 240 train cars, for the inter-city high-speed train "CRH5 EMU" project with speeds up to 250km/h.
- Stamford Tyres Corporation Ltd faced challenging business conditions for the year ended 30 April 2009 (FY2009). It however remained profitable with net earnings of \$1.1 million. The fall in profits for the year was primarily caused by foreign exchange losses of \$5.8 million and a \$2.7 million provision for doubtful receivables. FY2009 revenue was lower by 9.5% to \$296.9 million. This reflects the conditions prevailing across the entire automotive and tyre industries.

Local and Regional Markets Headline

Singapore share prices closed 2.37 per cent higher on Wednesday as investors bought into cheaper stocks following two straight days of losses, dealers said. Volume was thin however and there were no clear indications of where the market is heading, they said. The blue-chip Straits Times Index jumped 52.86 points to 2,278.96 on volume of 1.22 billion shares worth \$1.14 billion (US\$786 million). Gainers outgunned decliners 325 to 138, with 883 stocks unchanged.

Malaysian shares closed up 1.28 per cent on Wednesday driven by strong gains in property and construction stocks and selected blue chips, dealers said. The Kuala Lumpur Composite Index gained 13.37 points to 1,057.85. Advancers outpaced losers 594 to 120.

Hong Kong share prices closed 2.02 per cent higher on Wednesday, as investors grabbed bargains in property firms after a heavy fall in the previous session, dealers said. The benchmark Hang Seng Index closed up 353.78 points at 17,892.15. Turnover was low at HK\$56.71 billion (US\$7.27 billion).

Japan's Nikkei stock average rose 0.4 per cent on Wednesday as investors picked up some battered shares, with Softbank climbing after UBS Securities raised its target price for the issue. The Nikkei rose 40.71 points to 9,590.32, regaining a bit of ground after its 2.8 per cent slide on Tuesday. The broader Topix edged up 0.1 per cent to 902.46.

US Market News

The Dow Jones industrial average .DJI was down 23.05 points, or 0.28 percent, at 8,299.86. But the Standard & Poor's 500 Index .SPX was up 5.84 points, or 0.65 percent, at 900.94. The Nasdaq Composite Index.IXIC was up 27.42 points, or 1.55 percent, at 1,792.34.

In the U.S. Treasury bond market, the price of the benchmark 10-year note dropped 18/32 lower while its yield jumped to 3.70 percent from 3.63 percent late on Tuesday.

Data before the opening bell showed new orders for durable goods, which are long-lasting U.S. manufactured products such as refrigerators and washing machines, increased by a much stronger-than-expected 1.8 percent in May, and the median price of new homes hit its highest level since December, even though sales slipped.
