Fundamental Call

Property Sector (Alfred Low)

Recommendation: Overweight (Maintain)

• Record home sales in June 09. The Urban Redevelopment Authority (URA) data showed that private residential home sales rose to a record high of 1,825 units in June 2009. This surpassed the previous record of 1,723 units in August 2007. In fact, the recovery has started in February and continued for five straight months. We expect sales to remain strong for the rest of 2009.

Company Highlights

- Midas Holdings Limited announced that it has successfully raised gross proceeds of S\$90.6 million through a private placement of 120 million new ordinary shares representing 14.2% of the existing share capital of the Company, at the price of S\$0.755 per share. Net proceeds from the placement amounted to approximately S\$89.4 million, after deducting commission and estimated expenses. The Group intends to utilise approximately S\$81.0 million for the expansion of its aluminium alloy production capacity with the balance of approximately S\$8.4 million to be utilised for general corporate and working capital requirements.
- Mobileone Ltd reported that for the half year ended 30 June 09 ("1H09"), operating revenue at \$376.9m fell 7.9% YoY due to lower service revenue and handset sales. For 2Q09, it was 7.2% lower YoY at \$190.5m mainly due to lower service revenue. As at 30 Jun 09, Mobileone's cellular customer base stood 3.6% higher than last year. Market share was 25.5% at end May 09 as compared to 26.0% at end May 08 and 25.4% at end Feb 09. Net profit at \$37.1m for 2Q09 was 9.7% lower YoY due to lower service revenue partially offset by lower operating expenses.

Local and Regional Markets Headline

Singapore shares closed 0.49 per cent higher on Thursday, extending the previous day's gains sparked by a rally on Wall Street. The blue-chip Straits Times Index rose 11.60 points to 2,401.02 on volume of 1.97 billion shares worth \$1.81 billion (US\$1.25 billion).

Hong Kong share prices closed 0.57 per cent higher on Thursday, off earlier highs that were reached on the back of a Wall Street rally. The benchmark Hang Seng Index ended up 103.21 points at 18,361.87. Turnover was HK\$70.85 billion (US\$9.14 billion).

Japan's Nikkei average climbed 0.8 per cent on Thursday as high-tech exporters gained on a weaker yen and after results from Intel Corp lifted hopes for a rebound in technology spending. The benchmark Nikkei gained 74.91 points to 9,344.16 after peaking at 9,489.67. The broader Topix advanced 0.7 per cent to 872.25

Malaysian shares closed up 1.06 per cent on Thursday in line with gains on Wall Street. The Kuala Lumpur Composite Index gained 11.64 points to 1,108.88. Gainers outnumbered losers 398 to 304.

US Market News

U.S. stocks rallied for a fourth day on Thursday after JPMorgan's strong results fed growing optimism about the quarterly earnings season and technology shares rose in anticipation of more good news. Gains in International Business Machines Corp helped the market shake off its earlier malaise. The broad S&P 500 extended the week's gains to tally its best four days since March as stocks recovered from 12-year lows.

The Dow Jones industrial average rose 95.61 points, or 1.11 percent, to 8,711.82. The Standard & Poor's 500 Index gained 8.06 points, or 0.86 percent, to finish at 940.74, and has climbed 7 percent for the week so far. The Nasdaq Composite Index advanced 22.13 points, or 1.19 percent, to 1,885.03
