



Company Highlights

Leeden Limited announced a 34% growth in 1H09 revenue to S\$93.9 million. Net profit attributable to owners of the parent (PATMI) in 1H09 fell 37% to S\$5.0 million as the Group from S\$8.0 million in 1H08.

CapitaLand achieved profit after tax and minority interests (PATMI) of S\$124.0 million in 2Q2009 (excluding revaluations and impairments), a 163% increase compared to 1Q2009. Including aggregate losses on revaluations and impairments totalling S\$280.9 million taken in 2Q2009, the Group posted a 2Q2009 net loss after tax and minority interest of S\$156.9 million. Across the Group, 2Q2009 revenue was S\$591.1 million, bringing revenue for the six months ended 30 June 2009 to over S\$1 billion.

Pan Hong Property Group Limited announced it has won the tender for a land parcel in Huzhou city (Zhejiang Province) for a consideration of approximately RMB 221.3 million (S\$46.7 million). The acquired land parcel will be used for the development of residential and commercial properties.

Memstar announced that it has been awarded a maiden contract for an undisclosed contract sum (pursuant to a confidentiality agreement with DHT) to supply Ultra Filtration ("UF") membrane products for DHT's water treatment project.

Meghmani Organics Limited announced results for the first quarter ended June 30 2009. Revenue decreased 18.8% from Rs2.0 billion for the quarter ended June 30 2008 to Rs1.7 billion this year. PATMI increased 49.8% to Rs198.1 million from Rs132.2 million a year ago.

Technics Oil and Gas Ltd announced results for the quarter ended 30 June 2009. Group revenue increased by \$14.01 million or 53% year-on-year ("yoy") to \$40.24 million in the April to June 2009 quarter ("Q3 FY2009") compared to the corresponding financial period last year ("Q3 FY2008"). Net profit attributable to equity holders of the company soared 135% yoy to \$\$2.56 million in 3Q FY2009 from \$\$1.09 million in 3Q FY2008.

Singapore Post Limited announced its results for the first quarter for the financial year ending 31 March 2010. Revenue for the first quarter of FY 2009/10 increased marginally by 0.7% to S\$121.8 million. Net profit decreased 0.1% from \$38.9 million to \$36.9 million.

Suntec Real Estate Investment Trust announced results for the quarter ended 30 June 2009. Suntec REIT achieved gross revenue of S\$64.5 million for the quarter, which was 8.9% higher than in 2Q FY08. distribution income of S\$47.7 million for the period 1 April to 30 June FY09, which was 13.5% higher compared to the quarter ended 30 June 2008 (2Q FY08). The DPU of 2.977 cents for the quarter was 6.6% higher year-on-year.

China Eratat Sports Fashion Limited announced results for the quarter ended 30 June 2009. Revenue increased 52.9% to RMB259.7 million in the first quarter this financial year from RMB 169.8 million. Net profit increased by 24.7% to RMB35.4 million in FY10Q1 from RMB28.4 million in FY09Q1.

Achieva Limited issue profit guidance in anticipation of the release of the Group's second quarter results for FY2009 While the Profit from Operations is expected to be positive, the Group would post a Net Loss before Tax, as a result of foreign exchange losses. Such foreign exchange losses would include a one-time loss on the conversion of US dollar bank fixed deposits to Singapore dollar to pay the interim dividends of S\$20.8 million in June 2009. Despite hedging forward, this loss was incurred due to the significant weakening of the US dollar against Singapore dollar in the second quarter of FY2009.

Devotion Energy Group Limited announced that the Company and its subsidiaries (the "Group") are expected to report a loss for the 1st half year ended 30 June 2009 ("1H09"). The Group's 1H09 results were adversely affected by the current global economic slowdown. It has seen a significant drop in export sales of domestic wall-hung boiler as compared with the same period in 2008, and other business sectors of the Group also experienced weak demand.

China Sunsine Chemical Holdings Ltd announced its results for 2Q2009. Revenue increased 32.5% year-onyear to RMB177.7 million. Net profit after tax increased 133.9% from RMB10.9 million to RMB25.5 million.



Soup Restaurant Ltd announced results for the half year ended 30 June 2009. Group revenue increased by S\$2.3 million or 11.4% to S\$22.0 million for the half year ended 30 June 2009. Net profit attributable to shareholder decreased 34.2% from \$1.8 million to \$1.2 million.

Lereno Bio-chem Ltd announced results for the half year ended 30 June 2009. Revenue decreased 18% to S\$50,000 from \$61,000. The company recorded a net loss of \$2.2 million compared to a net loss of \$3.3 million in the same period last year.

Japan Land Ltd announced resuls for the quarter ended 31 May 2009. The company recorded revenue from continuing operations of \$1.9 million. It recorded a net loss attributable to shareholder of \$19.8 million.

CDL Hospitality Trusts announced its results for the second quarter ("2Q 2009") and first six months ("1H 2009") ended 30 June 2009. CDLHT achieved gross revenue of S\$20.2 million and an income available for distribution of S\$17.4 million in 2Q 2009, representing a decline of 31.5% and 30.6% respectively from the previous corresponding quarter ("2Q 2008"). In 1H 2009, CDLHT registered gross revenue of S\$42.8 million, a 25.6% decrease from the same period last year ("1H 2008"). Income available for distribution for 1H 2009 was S\$35.5 million, 26.8% lower than the S\$48.6 million in the same period last year. The income to be distributed per Stapled Security for 1H 2009 was 3.86 cents.

Local and Regional Markets Headline

Singapore shares closed higher on Thursday with the blue-chip Straits Times Index up 32.13 points to 2,636.19. Volume was 2.12 billion shares worth \$1.87 billion. Gainers led losers 335 to 185.

Malaysian shares closed down 0.33 per cent on Thursday on sustained profit-taking in blue-chips, dealers said. The Kuala Lumpur Composite Index lost 3.82 points to 1,160.66. Gainers outnumbered losers 353 to 240.

Hong Kong share prices closed 0.49 per cent higher on Thursday, due to mild bargain hunting after the previous day's correction, dealers said. The benchmark Hang Seng Index ended up 98.58 points at 20,234.08. Turnover was HK\$76.24 billion (US\$9.77 billion).

Japan's Nikkei average hit its highest close in nine months on Thursday, lifted by a surge for Honda Motor and Nissan Motor on surprise quarterly profits, but caution after a Chinese stock tumble weighed on gains. The benchmark Nikkei rose 0.5 per cent or 51.97 points to 10,165.21, its highest finish since Oct 6. The broader Topix added 0.7 per cent to 936.94.

US Market News

Stocks rose on Thursday as solid corporate profit reports and a drop in the number of Americans on jobless benefits gave investors reasons to buy equities following the S&P 500's two days of losses.

The market's rally pushed the benchmark S&P 500 index earlier in the session to its highest intraday level in almost nine months, putting it less than 4 points away from the psychologically important 1,000 level. The Nasdaq briefly rose above 2,000 for the first time since October.

The Dow Jones industrial average added 83.74 points, or 0.92 per cent, to close at 9,154.46. The Standard & Poor's 500 Index rose 11.60 points, or 1.19 per cent, to 986.75. The Nasdaq Composite Index gained 16.54 points, or 0.84 per cent, to 1,984.30.
