Fundamental Call

Cosco Corporation – Update (Alfred Low)

Recommendation: Sell (Maintain)

Previous close: \$\$1.30 Fair value: \$\$1.14

- 2Q FY2009 results. For 2Q FY2009, Cosco reported revenue of S\$718.5m (-31% yoy) and net profit of S\$37.0m (-71% yoy). There was lower revenue from ship repair, shipbuilding, marine engineering and dry bulk shipping. Net profit declined as a result of lower revenue and higher operational costs.
- Maintain SELL with fair value raised from \$\$0.91 to \$\$1.14. We maintain our sell recommendation on Cosco as it is expected to see more cancellations and rescheduling of ship deliveries. This is due to excess capacity in the shipping industry. However, as we expect the shipping industry to recover in 2010, we raise the fair value from \$\$0.91 to \$\$1.14, which is 2.2 times book value for FY2009F. This is a change from our earlier estimate of 1.5 times book value.

Technical

The STI is at heavy support at the 2700 region. This is the 50% retracement level from the 3907 high and March'09 1455 low, the 200 week moving average as well as the 2700 mark. We might see a short term pull back due to the confluence of these resistance levels. The Dollar has also fallen sharply and the possibility of a profit taking bounce might be in the cards. This would be in line with the short term pullback scenario.

Company Highlights

China Animal Healthcare Ltd. has turned in a strong set of results for the first half ended 30 June 2009 with its total revenue mainly boosted by a surge in sales of biological drugs. For HY2009, the Group reported a 3.6% increase in revenue to RMB175.7 million, while net profit attributable to equity holders was lower by 7.4% at RMB58.2 million.

Straits Asia Resources Limited reported another strong set of operational results for the first half of 2009. Sales revenue was up by 19% to US\$315 million and underscored the success of Straits Asia's decision to sell forward large quantities of its 2009 production before the global financial crisis had an impact on international coal markets. Production achieved was in line with expectations. Considerable efforts were applied to expansion of the nominal capacity at both operations in H1 2009 and as both expansions were completed on schedule, the infrastructure can be used in H2 2009. The Group is now on target for production of at least 9 million tones of coal this year. Gross profit for H1 2009 increased 42% to \$147 million demonstrating the continuing success of its coal business and robust margins that the Group has been achieving. Against this background of record revenue generation, net profit dropped slightly, by 2%, to US\$57 million from H1 2008



Sembcorp Marine delivered another quarter of continuous growth with an 8% increase in Group attributable profit to \$138.1 million from \$128.3 million in 2Q 2008. Group turnover registered an 8% increase to \$1,497.6 million as compared with \$1,386.1 million for the corresponding period in 2008. Group operating profit at \$166.7 million was 50% higher than the same quarter in the previous year. Group pre-tax profit increased 11% to \$178.9 million from \$160.7 million in 2Q 2008 attributable to higher operating margins from rig building projects, offset mainly by the lower contribution from Cosco Shipyard Group.

CSC Holdings Limited has posted Group revenue of \$81.4 million for the quarter ended 30 June 2009 (1Q10), compared to \$156.8 million in the corresponding period a year ago (1Q09), as uncertainties in the economic conditions resulted in significantly subdued demand for construction services. Net profit decreased 52.8% to \$6.7 million in 1Q10, from \$14.2 million in 1Q09. However, there was a slight improvement in net profit as compared to \$6.6 million recorded in the guarter ended 31 March 2009 (4Q09).

Eucon Holding Limited announced its results for the second quarter ended 30 June 2009. Group revenue declined by 50%, posting \$18.8 million in 2Q09 compared with \$37.8 million in 2Q08. The decrease was due to weak demand for electronics products as a result of severe global slowdown and reduced consumer spending. The Group reported a net loss of \$6.0 million for 2Q09, mainly attributable to high fixed costs and an additional provision of doubtful receivables amounting to \$\$0.9 million.

Yongmao Holdings Limited has make further forays in China's growing towercrane rental business with the establishment of a sino-foreign equity joint venture with Tat Hong Holdings Ltd and Mr Yuan Zheng, founder and major shareholder of Guangzhou Hailin Resource Co., Ltd, a prominent towercrane rental company in China. Yongmao will invest RMB28.35 million through its 45%-owned associated company, Beijing Tat Hong Zhaomao Equipment Rental Co. Ltd for an effective 20.25% ownership of the joint venture company, Si Chuan Tat Hong Yuan Zheng Machinery Construction Co., Ltd. BJTH is a joint venture incorporated on April 9, 2009 between Fushun Yongmao Construction Machinery Co. Ltd and Tat Hong's 100% subsidiary Tat Hong Equipment (China) Pte Ltd. BJTH, THEC and Mr. Yuan Zheng will hold an interests of 45%, 25% and 30% respectively in the JV Company. Yongmao's investment will be funded by its internal resources.

Local and Regional Markets Headline

After months of pursuit, Australia and New Zealand Banking Group (ANZ) has swooped down on some of Royal Bank of Scotland's (RBS) assets in Singapore and the region for US\$550 million. The deal is part of Australia-based ANZ's strategy to become a 'super-regional' bank. And despite stiff competition in Singapore's banking sector, it still sees pockets of opportunity for growth - catering to non- resident Indians and overseas Chinese, for instance. Paying just 1.1 times the assets' net tangible book value - or a US\$50 million premium - ANZ will get RBS's retail, wealth and commercial businesses in Singapore, Taiwan, Indonesia and Hong Kong. It will also gain control of RBS's institutional businesses in Taiwan, the Philippines and Vietnam.

Hard disk maker Seagate yesterday said 2,000 staff will be axed as it shuts its Ang Mo Kio factory and shifts its hard disk drive manufacturing operations to other countries by end-2010. At present, the company has about 8,000 staff here, a spokeswoman said. The Ang Mo Kio factory spans more than one million square feet and has a staff strength of about 4,000 employees, according to Seagate's website. In a statement to the media, Seagate said the consolidation is in order 'to further increase efficiency and reduce costs by leveraging investments across fewer manufacturing sites'.

US Market News

U.S. stocks edged higher on Tuesday, led by the financial sector as economic data pointed to a sustained if slow recovery from the recession, taking the Dow and the S&P 500 to nine-month highs. The Nasdaq achieved its highest close since early October. U.S. consumers spent more in June, though partly because of rising gasoline prices, and contracts to buy used houses rose more than expected and for a fifth-straight month. But income suffered its biggest drop in four-and-a-half years, underscoring fears over growing unemployment. The S&P financial index rose 2.1 percent as the housing data was a positive for the sector, while the Dow Jones Home Construction index gained 2.5 percent.



Indexes opened lower and seesawed throughout the session, but a late run-up helped extend the earnings-driven rally. Stocks soared about 40 percent from March to May but the surge wilted in June. Gains resumed at the start of the second-quarter earnings season. The broad S&P 500 index is up 48.6 percent from its 12-year closing low on March 9. On Tuesday, the Dow Jones industrial average gained 33.63 points, or 0.36 percent, to close at 9,320.19. The Standard & Poor's 500 Index rose 3.02 points, or 0.30 percent, to 1,005.65. The Nasdaq Composite Index edged up 2.70 points, or 0.13 percent, to end at 2,011.31.
