Fundamental Calls

Ho Bee – Results (Alfred Low) Recommendation: Hold (Maintain)

Previous close: \$\$1.10 Fair value: \$\$1.17

- **2Q FY2009 results.** Ho Bee reported 2Q FY2009 revenue of S\$740.8m (+534.2% yoy) and net profit of S\$157.3m (+325.6% yoy). It announced an interim dividend of S\$0.02 per ordinary share, which was an increase from S\$0.01 for the same period last year.
- Maintain HOLD recommendation, fair value raised from \$\$0.85 to \$\$1.17. We maintain our hold recommendation for Ho Bee as the share price has run up sharply in the recent rally and we believe that upside may be limited. Due to the improvement in sentiment in the property market, we raise the fair value from \$\$0.85 to \$\$1.17. This is based on a reduction in the discount from 50% to 40% of the RNAV. The RNAV has also been revised from \$\$1.71 to \$\$1.95 to reflect the higher than expected selling prices of the residential projects.

Company Highlights

- BBR Holdings (S) Ltd announced that it has secured a S\$104.2 million contract -- its first from the Housing & Development Board (HDB) to build seven blocks of flats, comprising 864 homes, in Yishun Neighbourhood 4. It is targeted to start next month and is scheduled to be completed in January 2012.
- Sinotel Technologies Limited announced that the Group has secured approximately RMB210.7 million worth of 3G related projects as at 31 July, 2009, i.e. approximately 60.6% of the Group's order book of RMB347.4 million as at 31 July, 2009.
- Straits Asia Resources Limited announced that the Indonesian government has formally completed a process for rezoning land use across South Kalimantan. The government decree for South Kalimantan includes a significant area within Straits Asia's Sebuku coal concession that was previously restricted from mining. That land has now been re-zoned as production forest and is therefore available for mining.
- Pan Hong Property Group Limited announced that it has placed 23.8 million new shares in the capital of the Company to the BOCOM International group, which is the investmentbanking and securities arm of Bank of Communications Co., Ltd. the Placement Shares have been placed to BOCOM International at a placement price of \$\$0.50 for each Placement Share.
- The Board of Directors of Advanced Integrated Manufacturing Corp. Ltd. announced that their direct subsidiary, Advanced Manufacturing Corporation Pte Ltd has been awarded a new contract with an estimated annual value of US\$5 million in addition to the existing contract from Honeywell International Inc.

Local and Regional Markets Headline

Singapore shares closed 3.25 per cent lower on Monday in line with other regional stocks after falling US consumer confidence reignited concerns over the strength of an economic recovery. The blue-chip Straits Times Index tumbled 85.53 points to 2,545.98 on volume of 2.34 billion shares worth \$1.73 billion (US\$1.19 billion). Among the blue chips, Singapore Airlines fell 38 cents to \$12.36 and Singapore Telecom was off 10 cents to \$3.13. Lender DBS was down 32 cents to \$12.60, Oversea-Chinese Banking Corp lost 22 cents to \$7.63 and United Overseas Bank retreated 40 cents to \$16.32. Property developer CapitaLand dipped 14 cents to \$3.56, shipping firm Neptune Orient Lines dropped eight cents to \$1.63 and publisher Singapore Press Holdings dropped nine cents to \$3.51.

Malaysian shares closed down 1.67 per cent. The Kuala Lumpur Composite Index shed 19.52 points to 1,169.05. Losers led gainers 701 to 93. Volume was moderate with 1.02 billion shares worth RM1.44 billion (US\$411 dollars) traded.

Hong Kong share prices tumbled to close 3.62 per cent. The benchmark Hang Seng Index closed 755.68 points lower at 20,137.65 on turnover worth HK\$74.74 billion (US\$9.64 billion).

Japan's Nikkei average fell 3.1 per cent on Monday on profit-taking in the wake of its rise to 10-month highs last week, with resource-linked shares such as Inpex Corp retreating due to a slide in oil prices. The Nikkei slid 328.72 points to 10,268.61, its lowest closing level in about two weeks, and down from a 10-month closing high of 10,597.33 on Friday. The Nikkei's 3.1 per cent slide was its biggest one-day percentage fall since late March. The broader Topix index fell 2.5 per cent to 949.59.

US Market News

U.S. stocks suffered their worst loss in seven weeks on Monday as weak data from Japan and a disappointing outlook from retailer Lowe's Cos dampened hopes about the economy's growth. U.S. selling was broad-based, but shares sensitive to the economy's cycles fell the most, including industrials, down 2.9 percent, and financials, down 4.3 percent. The Dow Jones index of home builders' shares fell 3.3 percent.

The Dow Jones industrial average dropped 186.06 points, or 2 percent, to end at 9,135.34. The Standard & Poor's 500 Index slid 24.36 points, or 2.43 percent, to 979.73. The Nasdaq Composite Index lost 54.68 points, or 2.75 percent, to 1,930.84.

The Dow and the S&P 500 had their worst one-day percentage sell-offs since July 2, while the Nasdaq had its worst since June 22. The S&P 500, however, is still up about 45 percent from its early March lows.
