#### **Company Highlights**

- **Hyflux Ltd** announced that it has signed a Memorandum of Understanding ("MOU") with the Japan Bank for International Cooperation for global collaboration on water projects.
- **ASL Marine Holdings Ltd.** announced an 18% rise in earnings to S\$71.1 million for the year ended 30 June 2009. Total revenue for the Group increased by 9% to S\$435.4 million in FY2009 due to all three business segments, namely shipbuilding, shiprepair and shipchartering, registered comparatively higher revenue during the year.
- The Board of Directors of Sino Construction Limited announced that its operating subsidiary in Daqing was successful in the tender and the subsequent award of the following construction contracts by its customers: (1) Construction of a highway intersection in Daqing City, contract value of RMB153.6m, (2) Construction of 2 commercial clusters with contract value of RMB210.9m, (3) Separate contracts for the construction of a factory premise, a building block used by an educational institute and infrastructural works for a water treatment plant with contract value of RMB79.7m bringing the total contract value to RMB444.2m. The Group also announced that the commencement of work for 2 separate contracts amounting in aggregate of about RMB 524.7 million have been delayed indefinitely.
- Asian Micro Holdings Limited announced that for financial year ended 30 June 2009 in August 2009, the Board of Directors of the Company deems it appropriate to issue a loss guidance.

#### **Local and Regional Markets Headline**

Singapore shares closed lower on Wednesday with the blue-chip Straits Times Index down 44.94 points to 2,522.78. Volume was 2.56 billion shares worth \$1.68 billion. Losers led gainers 350 to 162.

#### **US Market News**

U.S. stocks rose on Wednesday, shaking off a slide in China's equity market, as investors responded favorably to a surprising drop in crude oil stockpiles that might suggest an improving demand outlook. Wall Street had opened lower after the Shanghai Composite index fell to a two-month low as investors fretted that China's 20 percent slide over the past two weeks would continue. The Dow Jones industrial average gained 61.22 points, or 0.66 percent, to 9,279.16. The Standard & Poor's 500 Index rose 6.79 points, or 0.69 percent, to 996.46. The Nasdaq Composite Index advanced 13.32 points, or 0.68 percent, to 1,969.24.
