Fundamental Call

Epure International Limited – Results Update (Mark Chow)

Recommendation: BUY Previous close: \$\$0.60 Fair value: \$\$0.71

• Reiterate BUY at fair value estimate of \$\$0.71. We are still bullish on the China water demand play and now with the Middle East in the picture, the Group is likely to open more doors in that region. We thus maintain our BUY stance at an adjusted fair price of \$\$0.71 which represents an 18.3% upside potential from its last traded price of \$\$0.60.

The STI is trading within the range of the week ending 7August09 (2700 and 2542). For there to be clear directional movement we will need to see a clean breakout in either direction. The S&P 500's price action indicates that it might be in the midst of putting in a top. Should we see a weak CRB and a falling S&P 500, the STI should follow suit and decline as well.

Company Highlights

- Noble Group Ltd announced that it has signed a mandate letter with nine financial institutions to arrange for the extension of its US\$1.2 billion Committed Unsecured Revolving Loan Facility for an additional one and two years; and to seek commitments for a new US\$600 million 364-day Committed Unsecured Revolving Loan Facility. The proceeds will be used for general corporate purposes.
- Ying Li International Real Estate Ltd proposed a private placement of up to 107,143,000 new ordinary shares at S\$0.28 for each placement share. The proceeds will be used for development of international financial centre, repayment of bank loans and general working capital.
- C & O Pharmaceutical Technology (Holdings) Ltd reported a 1.4% decrease in net profit to HK\$108.8m and 2.9% decrease in revenue to HK\$548.6m for the year ended 30 June 2009. The decline in revenue was due to the disposal of interest in Cang Nan Province Hong Tai Pharmaceutical Company Ltd, which is offset by increase in sales of both exclusive and C & O branded products and increase in sale of technical knowhow. Net profit was lower due to higher expenses offset by lower cost of goods sold.
- Pacific Andes Resources Development Ltd and China Fishery Group Ltd announced the change of financial year end to 28 September.



- Goodpack Ltd reported a 12.1% decrease in net profit to US\$25.9m and 2.9% increase in revenue to US\$102.4m for the year ended 30 June 2009. Revenue increased due to improvement in the synthetic rubber and liquids sectors offset by lower demand from the natural rubber sector. Profit fell due to lower other operating income and higher depreciation expense.
- Tiong Woon Corporation Holding Ltd reported a 51% increase in net profit to S\$42.3m and 28% increase in revenue to S\$202.3m for the year ended 30 June 2009. Revenue rose because of higher revenue from heavy lift and haulage segment and fabrication and engineering segment offset by lower revenue from marine transportation segment and trading segment. Profit was higher mainly due to higher revenue.
- Swissco International Ltd has acquired 49% stake in SW Marine (M) Sdn Bhd for a cash consideration of RM49,000. SW Marine is a ship operator and the joint venture will allow Swissco to establish a direct presence in Malaysia.
- Magnus Energy Group Ltd (the "Company" and together with its subsidiaries, the "Group") deems it appropriate to announce that the Group is expecting to report a loss for the 4th quarter and full financial year ended 30 June 2009. The Board expects the Group to report a loss which is mainly due to impairment loss of the coal and oil concession rights, impairment loss of oilfield assets, and the exchange loss arising from the revaluation of fixed deposits and trade debtors denominated in United States dollars and Australian dollars.
- Teho International Inc Ltd announced a 5% decrease in net profit to S\$7.6m and 9% increase in revenue to S\$38.5m for the year ended 30 June 2009. There was increase in revenue from marine and other segments offset by lower revenue from offshore oil and gas segment. Profit fell due to lower selling prices and higher product costs.
- Hai Leck Holdings Ltd announced a 76.7% decrease in net profit to S\$11.0m and 56.6% increase in revenue to S\$105.0m for the year ended 30 June 2009. There was higher revenue from project services. Profit was lower due to higher operating expenses. It also proposed a renounceable non-underwritten rights issue of warrants at the price of S\$0.01 per warrant on the basis of one warrant for every three existing shares. Each warrant carries the right to subscribe for one new ordinary share at an exercise price of S\$0.26.
- Portek International Ltd announced a 119.3% increase in net profit to S\$8.6m and 1.0% decrease in revenue to S\$138.9m for the year ended 30 June 2009. There was lower revenue from Port Equipment Engineering offset by higher revenue from Port Operations and Management. Profit was higher due to better gross margins.

Local and Regional Markets Headline

Singapore shares closed 0.37 per cent higher on Wednesday as underlying sentiment remained firm, supported partly by signs of a recovery in the key manufacturing sector, dealers said. The blue-chip Straits Times Index added 9.67 points to 2,628.43. Volume totaled 3.18 billion shares worth \$1.78 billion (US\$1.23 billion). There were 357 rising issues, 183 losers while 825 issues were steady.

Malaysian share prices closed up 0.13 per cent on Wednesday after the market received a boost from late buying interest by local funds, dealers said. The Kuala Lumpur Composite Index gained 1.47 points to 1,172.56. Gainers outpaced losers 363 to 260.

Hong Kong share prices closed 0.10 per cent higher on Wednesday as investors welcomed upbeat economic data out of the United States and a rise in Chinese stocks. The benchmark Hang Seng Index finished 21.08 points better off at 20,456.32. Turnover was HK\$55.30 billion (US\$7.14 billion).

Japan's Nikkei stock average hit its highest close in 10 months on Wednesday after US data strengthened hopes for an economic recovery, but trade was cautious ahead of an Aug 30 election in Japan. The benchmark Nikkei gained 1.4 per cent to 10,639.71, its highest close since Oct 3. The broader Topix added 1.1 per cent to 975.59.

The Nasdaq Composite Index ended up just 0.20 points, or 0.01 percent, at 2,024.43.






