#### **Company Highlights**

- **Singapore Airlines Ltd** announced that it has agreed with Airbus on a revised delivery schedule for eight A380 aircraft on firm order. The revised schedule will see the 12<sup>th</sup> aircraft delivered in October 2010 rather than April 2010, while the 19<sup>th</sup> aircraft will be delivered in January 2012 rather than January 2011.
- China XLX Fertiliser Ltd announced that it has served notice to AMN AMRO on its intention to repay the three-year US\$45 million syndicated loan which the Company obtained in the third quarter of 2008. Under the terms of the notice, the Company proposes to repay the Syndicated Loan by 30 September 2009.
- China Precision Technology Limited to seek the voluntary delisting from the Mainboard of the Singapore Exchange Securities Trading Limited. The offer price for each share is \$\$0.28.

#### **Local and Regional Markets Headline**

Singapore shares closed 1.11 per cent higher on Thursday on gains in selected chips, dealers said. The blue-chip Straits Times Index rose 28.43 points to 2,598.36. Volume totalled 2.82 billion shares worth \$1.81 billion.

Malaysian shares prices closed up 0.48 per cent on Thursday on gains in finance and property blue-chips, dealers said. The Kuala Lumpur Composite Index gained 5.65 points to 1,173.66. Advancers outnumbered losers 454 to

Hong Kong share prices closed 1.23 per cent higher on Thursday, tracking strong gains on mainland China's market despite an overnight tumble on Wall Street, dealers said. The benchmark Hang Seng Index finished 239.68 points higher at 19,761.68. Turnover was HK\$57.77 billion (US\$7.41 billion).

Japan's Nikkei stock average lost 0.6 per cent on Thursday as exporters fell on worries about the US economy after dismal jobs data, while Dainippon Sumitomo Pharma rose on news it would bid for a US drug firm. The benchmark Nikkei lost 65.82 points to 10,214.64, while the broader Topix fell 0.7 per cent to 942.77.

U.S. stocks rose on Thursday, snapping a four-day losing streak, after stronger-than-expected retail sales data eased concerns about the economy before Friday's important jobs data. The Dow Jones industrial average was up 63.94 points, or 0.69 percent, at 9,344.61. The Standard & Poor's 500 Index .SPX was up 8.49 points, or 0.85 percent, at 1,003.24. The Nasdag Composite Index was up 16.13 points, or 0.82 percent, at 1,983.20.
