Fundamental call

Yingli International Real Estate Limited – Update (Brandon Ng)

Recommendation: Buy Previous close: \$\$0.895 Fair value: \$\$1.270

- Yingli announced that they have acquired another prime area in Yuzhong, Chongqing through a government land auction for RMB 851.6 million and to develop it into an integrated development project, with high-end residential, hospitality, as well as high-grade retail component.
- Construction costs will amount to approximately RMB 750 million and they will sell the residential properties but retain the retail portion as investment properties. Using a ballpark selling price and rental for its residential and retail properties, we gauge that this project will add NPV of approximately RMB 3065 million to the company.
- We add the new project into our valuation model to arrive at a RNAV of S\$1.270 and maintain our BUY rating.

- Yanlord Land Group Limited wishes to announce that it has through its wholly-owned subsidiary, Yanlord Land
 Pte. Ltd., set up a joint venture company in Singapore with HB Investments (China) Pte. Ltd. The JV Company
 is undertaking a feasibility study on a property development project in the Peoples' Republic of China. The
 initial issued share capital of the JV Company is US\$100,000.
- CapitaLand Limited wishes to announce that its indirect subsidiaries, CapitaLand (Tianjin) Co., Ltd. and Beijing CapitaLand Property Management Co., Ltd have each acquired (the "Acquisition") 5% stake in Beijing Rising Harmony Real Estate Development Co., Ltd. ("Beijing Rising Harmony") from its existing shareholders unrelated to CapitaLand (the "External Parties"). Beijing Rising Harmony, a company incorporated in the People's Republic of China, owns the right to develop a residential site in Changping District, Beijing. Its principal activity is that of real estate development, sales and property management.
- Main board-listed Beyonics Technology Limited announced financial results for the financial year ended 31 July 2009. The Group recorded a profit attributable to equity holders of S\$0.8 million in Q4 FY2009 after incurring a loss of S\$2.6 million in Q3 FY2009. Revenue in Q4 FY2009 was 17.2% lower than that in Q4 FY2008 but 13.6% higher than that in Q3 FY2009.
- China Sunsine Chemical Holdings Ltd wishes to comment on the U.S. tariffs on tyres imported from China. On 11 September 2009, U.S. Government announced its decision to impose a tariff on passenger vehicle and light truck tyres imported from China. The tariff will be 35% for the first year, 30% for the second year and 25% for the third year with effect from 26th September 2009, on the top of current 4% duty. In fact, the Group has highlighted the potential protectionist action by the U.S. Government on Chinese tyre manufacturers as a risk factor or concern in its 2Q2009 results announcement.



Fibrechem Technologies Limited wishes to announce that the application to place the Company into liquidation
has been withdrawn without prejudice to the applicant's rights. The withdrawal of the Winding Up Application
has afforded the Company an opportunity to restructure its financial obligations and rehabilitate its operations.

Local and Regional Markets Headline

Singapore has now signed nine of the 12 tax treaties that it needs to get off the 'grey list' of the Organisation for Economic Cooperation and Development (OECD) and onto the white. These treaties are compliant with the internationally-agreed tax standard on exchange of information (EOI). The speed with which governments worldwide have moved to pass required legislation and sign treaties speaks of the reputational implications that being left on the grey list could have. Already, areas traditionally thought of as tax havens for low or zero tax rate regimes, such as the British Virgin Islands and Cayman Islands, have made the white list. Though not seen as a traditional tax haven, Singapore is still listed as a 'financial centre' on the grey list of jurisdictions which have committed to the standard but have yet to substantially implement it. Switzerland, which was also on the list, has already signed 12 tax treaties and says that it has been taken off the OECD list. Singapore hopes to take the same path.

CHICAGO) The US government is stepping up prosecutions of wealthy individuals dodging taxes through offshore accounts, with new cases expected to be made public 'every couple of weeks', a top government lawyer said on Saturday. US officials have been sifting through about 250 client names obtained through a February settlement of a criminal probe against Swiss banking giant UBS AG. The government had alleged the bank illegally helped US taxpayers hide funds offshore. That effort, along with an amnesty programme encouraging tax evaders to turn themselves in, is speeding prosecutions, one of the top lawyers working on the cases at the US Justice Department said.

US Market News

U.S. stocks fell for a third straight day on Friday after disappointing data on durable goods orders and housing, while Research In Motion's lackluster results dented optimism about tech spending. According to the latest available figures, the Dow Jones industrial average was down 42.25 points, or 0.44 percent, at 9,665.19. The Standard & Poor's 500 Index fell 6.40 points, or 0.61 percent, at 1,044.38. The Nasdaq Composite Index closed down 16.69 points, or 0.79 percent, at 2,090.92. The three indexes marked their biggest weekly percentage drops since early July. The Dow was down 1.6 percent for the week while the S&P was down 2.2 percent and Nasdaq fell 2 percent for the week.
