Economics

Economic Update - USA

Employment-Consumption is king now.

- We repeat again: Unemployment is not the lagging indicator it used to be, but in a credit deflation scenario in a consumption based economy, it is a leading indicator
- Chronic unemployment taking hold as those unemployed for more than 27wks continue to increase in proportion and absolute numbers (5.4m)
- Unemployment Rate rises to 9.8% and net jobs lost increase to 263k from 201k
- The economy is actually on track given our view of a tepid recovery with a double-dip, but since the S&P500 has priced in a V-recovery, it will continue to be terribly disappointed

Technical

The STI has broken out from the 2615 level we mentioned last week and the bias for the STI seems to be shifting from neutral to down. We are likely to see the STI make lower highs & lows intraday as it moves towards 2542 and expect a volatility expansion if 2542 is breached. The CRB is forming a breakout pattern. A strong downward break would weigh on stocks while an upward one would likely stall the decline.

Local and Regional Markets Headline

Singapore shares closed lower on Monday with the blue-chip **Straits Times Index** down 20.80 points to 2,583.73. Volume was 2.35 billion shares worth \$1.58 billion. Losers led gainers 526 to 89.

Hong Kong share prices closed 0.26 per cent higher on Monday as bargain hunting by investors offset concerns about the pace of a US economic recovery, analysts said. The benchmark **Hang Seng Index** finished 53.58 points higher at 20,429.07. Turnover was HK\$43.68 billion (US\$5.65 billion).

Japan's **Nikkei** average fell 0.6 per cent to hit an 11-week closing low on Monday, dented by shares of exporters on concerns over the fragility of the US economic recovery and lingering worries about the yen's recent strength. The Nikkei slipped 57.38 points to 9,674.49, its lowest finish since July 21. The broader Topix declined 0.8 per cent to 867.28.

Malaysian shares closed up 0.85 per cent on Monday on bargain-hunting in finance and plantation stocks, dealers said. The **Kuala Lumpur Composite Index** gained 10.20 points to 1,216.45. Losers outnumbered advancers 351 to 235.

The Institute for Supply Management's index for the U.S. services sector rose to 50.9 in September, crossing the 50 threshold that indicates expansion and topping expectations. The services sector represents about 80 percent of the U.S. economy.

The Dow Jones industrial average .DJI was up 112.08 points, or 1.18 percent, at 9,599.75. The Standard & Poor's 500 Index .SPX was up 15.25 points, or 1.49 percent, at 1,040.46. The Nasdaq Composite Index .IXIC was up 20.04 points, or 0.98 percent, at 2,068.15.
