Fundamental call

Across the board, equity indices have simultaneously tagged key resistance levels. This is the most likely reason for the general slow down in Friday's (16Oct09) trading. Currently, we would like to see the STI push beyond key resistance in the 2730 to 2746 region. We should see a volatility expansion if the STI manages to breakout above the 2730 to 2746 level that is currently capping its upside.

Local and Regional Markets Headline

The blue-chip **Straits Times Index** gained 3.58 points to 2,711.70 on volume of 1.69 billion shares worth \$1.13 billion (US\$810 million). Gainers outnumbered losers 251 to 196, with 823 stocks unchanged.

The benchmark FTSE-Bursa Malaysia **Kuala Lumpur Composite Index** gained 4.72 points, or 0.38 per cent, to close at 1,261.49 on Monday. Turnover was at 1.334 billion shares valued at RM1.267 billion (US\$381.375 million). Gainers led losers by 439 to 291.

Hong Kong stocks closed up at a 14-month high on Monday, spurred by optimism that China is on track to meet its growth forecast, while Foxconn International rallied on a rosy outlook for the handset industry. The benchmark **Hang Seng Index** rose 1.23 percent, or 270.56 points to 22,200.46, the highest since August 2008. The China Enterprises Index of top locally listed mainland Chinese stocks was up 1.54 per cent at 12,947.73.

The benchmark **Nikkei** edged down 21.05 points to 10,236.51 after earlier falling as much as 1.3 per cent. The broader Topix rose 0.5 per cent to 905.80.
