#### **Company Highlights**

- Lum Chang Holdings Limited wins SGD46.5 million construction deal to build new industrial development in Tuas. Project is awarded by Dril-Quip Asia Pacific Pte Ltd and is expected to complete in 16 months time.
- United International Securities Limited recorded a higher net profit after tax of \$14.9 million in the first 9 months of 2009 as compared to \$13 million recorded in the first nine months of 2008. The increase in net profit was due mainly to higher foreign exchange gain, lower loss on trading securities, surplus on liquidation of subsidiary and writeback of impairment, partially offset by loss from sale of non current investments and lower dividend income.

#### **Local and Regional Markets Headline**

The blue-chip **Straits Times Index** (STI) eased 0.61 points to 2,711.09 on volume of 1.98 billion shares worth \$1.29 billion (US\$928 million). Decliners outnumbered risers 305 to 194, with 771 issues unchanged.

The **Kuala Lumpur Composite Index** gained 4.25 points to a new 2009 closing high at 1,265.74. Dealers said trading was robust with volume of 1.24 billion shares while decliners outpaced gainers 419 to 329.

The benchmark **Hang Seng Index** finished up 184.50 points at 22,384.96. Turnover was HK\$74.18 billion (US\$9.57 billion). Dealers sent the market to its best finish since August 4 last year on confidence over upcoming third-quarter corporate data. Analysts expect the market to test 22,500 points this week.

The benchmark **Nikkei** rose 1 per cent to 10,336.84, its highest finish since Sept 24. The broader Topix gained 0.8 per cent to 913.45. Japan's Nikkei average hit its highest close in three weeks on Tuesday, buoyed by tech shares such as Kyocera Corp after a wave of solid US earnings helped underscore that the economic recovery continues.

New construction of U.S. homes rose less than expected in September and U.S. producer prices posted an unexpected decline, both pointing to an anemic economic recovery.

Blue-chip Dow Jones industrial average dropped 50.71 points, or 0.50 percent, to end at 10,041.48. The Standard & Poor's 500 Index fell 6.85 points, or 0.62 percent, to 1,091.06. The Nasdaq Composite Index shed 12.85 points, or 0.59 percent, to close at 2,163.47.
