Fundamental call

Suntec REIT - 3QFY09 results (Lee Kok Joo)

Recommendation: HOLD Previous close: S\$1.18 Fair value: S\$1.13

• Suntec REIT reported gross revenue for 3QFY09 of \$61.9 million (flat y-o-y, -3.9% q-o-q)), net property income (NPI) was \$47.0 million (+3.1% y-o-y, -3.6% q-o-q). Distributable income was \$47.7 million (+8.8% y-o-y, flat q-o-q). DPU for the quarter was 2.921 cents (+2.3% y-o-y, -1.9% q-o-q).

Company Highlights

- CapitaLand Ltd posted profit after tax and minority interests ("PATMI") of S\$281.3 million for the third quarter ended 30 September 2009 compared to S\$419.4 million in the third quarter ended 30 September 2008 which benefited from substantial divestment gains. Operationally, it has performed significantly better this quarter than the previous two quarters. Excluding the impact of revaluations and impairments taken in the second quarter ended 30 September 2009, PATMI grew 127% in the third quarter ended 30 September 2009 to reach S\$281.3 million, compared to S\$124.0 million in the second quarter ended 30 September 2009. Revenue for the third quarter ended 30 September 2009 was up 75% to S\$1,046.2 million on the back of strong revenue recognition for residential projects in Singapore, China and Vietnam.
- FM Holdings Ltd (the "Company") announced that it has entered into a Subscription Agreement ("the Subscription Agreement") with Advance Opportunities Fund (the "Subscriber") and Value Capital Asset Management Private Limited as the Investment Manager of the Subscriber (the "Investment Manager") to issue to the Subscriber, 1% equity-linked redeemable structured notes due 2012 in aggregate principal amount of up to \$\$15,000,000, convertible into a maximum of 444,733,073 new ordinary shares in the capital of the Company (the "Conversion Shares") over a period of three years.
- Oceanus Group Ltd (The "Company") announced that it is considering a proposal to offer and list Taiwan Depository Receipts ("TDR") representing an aggregate of up to 200 million shares of the Company on the Taiwan Stock Exchange (the "TDR Shares", and the "Proposed TDR Issue" respectively). The TDR Shares shall comprise not more than 100 million new shares (the "New Shares") to be issued by the Company and not more than 100 million shares from the investors who had participated in the recent financing exercise (the "Investors", and the "Financing Exercise" respectively) undertaken by the Company, pursuant to which the Company raised a total of \$\$73.5 million in loans and issued a total of 490 million warrants to the Investors. The Investors will provide the relevant Shares for the Proposed TDR Issue (the "Investor Shares") by exercising an equivalent number of warrants issued to them during the Financing Exercise.



- Pine Agritech Ltd (the "Company") informed that following a preliminary assessment of the unaudited consolidated financial results, the Company expects to report a loss for the third quarter ended 30 September 2009. The Company's financial results continue to be adversely affected by the global economic slowdown, mainly attributable to the lower export volume and the decrease in export sales. In addition, the global economic slowdown has also resulted in weaker domestic demand for our products, which affected the Company's overall performance for the third quarter ended 30 September 2009.
- Singapore Technologies Engineering Ltd (ST Engineering) announced that its U.S. company, Vision Technologies Systems, Inc. (VT Systems), has acquired the remaining 51% equity stake in Ximaera Technologies Canada, Inc. (Ximaera) through its wholly owned subsidiary, VT iDirect, Inc. (iDirect). iDirect first acquired a 49% share in Ximaera in 2006. The remaining 51% stake has been acquired for a cash consideration of US\$396,000. The purchase consideration was arrived at between iDirect and the shareholders on a willing buyer, willing seller basis. With the acquisition, Ximaera has become a wholly-owned subsidiary of iDirect and will be renamed VT iDirect Canada, Inc.
- Manufacturing Integration Technology Ltd ("MIT") is pleased to announce that the Company has just shipped out its first line of LS 800 laser scribers to an Asian customer. This is its first commercial sale of laser scribers to the solar industry since the product was launched on 31 August 2009. MIT's LS 800 laser scribers are used by manufacturers of solar panels utilizing thin film based technology. According to the PV Status Report (August 2009) by the Joint Research Centre, the Photovoltaic industry production reached a worldwide volume of 7.3GWp of Photovoltaic modules in 2008 with yearly growth rates averaging more than 40% over the last decade.
- **Ezra Holdings Ltd** ("Ezra") wishes to announce that together with **KTL Global Ltd** ("KTL"), a joint venture will be set up to design, produce and supply mooring systems for the offshore oil and gas industry. The joint venture will take the form of a new company, Advance Mooring Systems Pte. Ltd. ("AMS"), whose share capital will be held in equal proportions by KTL and LMC Asia Pacific Pte Ltd ("LMC"), a subsidiary company of London Marine Group Limited, whose ultimate holding company is Ezra Holdings Ltd. KTL and LMC each will apply and subscribe for or acquire 5,000 shares of US\$1 each in AMS for the consideration of US\$5,000. Thereafter, AMS will be an associated company of Ezra.
- China Essence Group Ltd (the "Company") wishes to announce that the Group has entered into Facility Agreements with Bank of Communications and Agricultural Bank of China in October 2009 in respect of a total of RMB 200 million short-term loans (the "Term Loans"). The Term Loans are not secured against any of the assets of the Company and shall mature one year from the date of grant of the facilities. The Term Loans will be used to meet the working capital requirements of the Company.
- Singapore Tianjin Eco-City Investment and Development Co., Ltd. ("SSTEC") is a 50/50 joint venture between the Chinese Consortium led by Tianjin TEDA Investment Holdings Co. Ltd and the Singapore Consortium led by the **Keppel Group**. SSTEC has joined hands with one of Malaysia's top developers, Sunway City Berhad (SunCity), to pursue the development of a large project in Tianjin Eco-City, China, with an estimated gross development value of more than RMB 5 billion (RM 2.48 billion / approximately S\$1.02 billion).
- Lian Beng Group has bagged a \$112.7 million contract for the construction of The Gale, a freehold condominium development located on Flora Road. The design-and-build contract was awarded by Tripartite Developers Pte Ltd (part of the Hong Leong Group) and covers the construction of 329 apartment units within nine 8-storey blocks, together with a basement carpark, clubhouse, swimming pool and other communal facilities. Work on the development is expected to commence in November 2009 and be completed by November 2012.
- Suntec REIT reported a 0.8% increase in gross revenue to S\$61.9 million and 3.1% increase in net property income to S\$47.0 million for the third quarter ended 30 September 2009. It announced that the distribution per unit is 2.921 Singapore cents for the period.
- Hong Leong Asia Ltd ("HLA" or the "Company") announced that Well Summit Investments Limited ("Well Summit"), a wholly owned subsidiary of the Company, had between 22 and 26 October 2009, purchased in the open market an aggregate of 2,035,237 ordinary shares of US\$0.10 each in the capital of China Yuchai



International Limited ("CYI") (a company listed on the New York Stock Exchange), representing approximately 5.46% of the issued and paid-up share capital of CYI, for an aggregate cash consideration of US\$23,213,564.95. The consideration was funded by a combination of internal funds and bank borrowings. Following the said purchases, the HLA group holds in aggregate 9,949,007 CYI shares (inclusive of 1 special share of US\$0.10 in CYI) representing approximately 26.70% of the issued and paid-up share capital of US\$3,726,767.40 comprising 37,267,673 ordinary shares and 1 special share of CYI as at 26 October 2009.

Cambridge Industrial Trust reported a 2.1% increase in gross revenue to S\$18.7 million and 0.9% increase in net property income to S\$16.4 million for the third quarter ended 30 September 2009. It announced that the distribution per unit is 1.344 Singapore cents for the period.

Local and Regional Markets Headline

Singapore shares closed 0.81 per cent lower on Tuesday as sentiment turned cautious following Wall Street's tumble, dealers said. The blue-chip Straits Times Index fell 22.12 points to 2,694.50. Volume totaled 1.52 billion shares worth \$1.26 billion (US\$906 million) while there were 117 rising issues, 408 losers and 821 flat.

There were 264 gainers, 404 losers and 229 counters traded unchanged on the Bursa Malaysia. The FTSE-Bursa Malaysia KLCI closed at 1,260.30, up 0.38 of a point.

Hong Kong shares dropped 1.86 per cent on Tuesday following a tumble on Wall Street. The benchmark Hang Seng Index finished 420.14 points lower at 22,169.59.

Japan's Nikkei average lost 1.5 per cent for its biggest one-day percentage fall in three weeks on Tuesday as trading houses fell after oil prices slid and Astellas Pharma was hurt by a brokerage downgrade. The benchmark Nikkei shed 150.16 points to close at 10,212.46 in its biggest one-day percentage loss since Oct 2, while the broader Topix lost 1.7 per cent to 895.48.

The S&P 500 and the Nasdaq fell on Tuesday as investors booked profits following the stock market's recent runup, while a weaker-than-expected reading on a measure of consumer confidence sparked caution about the recovery of spending. The Dow Jones industrial average gained 14.21 points, or 0.14 percent, to 9,882.17. The Standard & Poor's 500 Index fell 3.54 points, or 0.33 percent, to 1,063.41. The Nasdaq Composite Index declined 25.76 points, or 1.20 percent, to 2,116.09.
