Fundamental Call

China Milk Products Group Ltd – Results (Lee Kok Joo) Recommendation: SELL Previous close: S\$0.375 Fair value: S\$0.30

- The aftermath of the milk scandal has left a scarring effect on China Milk Products Group Ltd (CMP). Revenue has seen a drastic decline ever since the scandal broke out and it seems that confidence in the local milk produce may take a long while to recover.
- CMP posted a disappointing 2QFY10 performance. Revenue fell a whopping 75.2% from a year ago. Revenue decline was broad base over the three product segments. For each of the product segment, sales of raw milk fell 19.2%, bull semen sales fell 91.6% and there were totally no sales for cow embryos. In fact since the milk scandal in 2008, revenue has been on a decline and bull semen, which used to account for 65% of total revenue fell to just 21% in 2QFY10.

Company Highlights

- Jaya Holdings Ltd reported 1st quarter ended 30 September 2009 revenue of S\$40.4 million or 36% lower than that of the previous corresponding quarter. The Group's net profit attributable to equity holders of the company for 1Q09 improved to S\$32.5 million from S\$9.1 million a year ago. This was primarily due to an accounting charge of S\$27.0 million arising from the marked to market valuation of the Group's foreign exchange position and higher extraordinary gains from vessels disposal.
- Eucon Holding Ltd reported a 46% decrease in revenue to \$54.2 million for its third quarter results. Net loss for 9M09 was \$10.8 million from a net profit of \$1.0 million a year ago. This was mainly due to weak demand for electronics products as a result of global economic slowdown and reduced consumer spending.
- FJ Benjamin Holdings Ltd announced that turnover for its 1st quarter declined by 20% to \$67.6 million from \$84 million about a year ago. Net profit fell 58% year on year to \$459,000 as a result of weak consumer sentiment in key markets in Asia.
- Synear Food Holdings Ltd announced that its 3Q09 revenue declined 16.2% to RMB1,362.9 million, impacted by the challenging business environment in the first half of 2009. Net profit decreased 38.6% to RMB128.7 million in 9M09.
- United Food Holdings Ltd reported a net loss of RMB86.8 million from RMB28.2 million a year ago. Revenue slipped 36.45% to RMB1, 426.2 from RMB 2,244.398. This was mainly due to decrease in demand for its animal feed, pedigree pigs as well as lower average selling prices of soybean meal and soybean oil.



- Fortune REIT announced a 5.1% increase in net property income to HK\$118.6 million for the quarter ended 30 September 2009 over the same quarter last year. Distributable income increased by 14.1% to HK\$81.2 million from a year ago. This was due to improving occupancy with positive rental reversion.
- **Sembcorp Marine Ltd** unveiled plans to develop a modern, cost-efficient and integrated New Yard Facility to position the Group for sustainable growth and expansion of its marine and offshore businesses.
- Sing Investments & Finance Ltd said its third quarter net profit doubled to \$4.31 million from \$2.14 million a year earlier, as interest expenses fell faster than its interest income and hiring charges. Net profit rose 59% to \$12.7 million compared to a year earlier.
- Elec & Eltek International Company Ltd announced its net profit rose 15.7% to US\$14.16 million as shipments picked up along with the economy. Revenue however fell 15.2% to US\$119.77 million.
- Sembcorp Marine Ltd reported net profit for its fiscal third quarter rose 2.6% to S\$144.6 million from S\$140.9 million last year. Turnover rose 32.9% to S\$1.52 billion from S\$1.14 billion a year ago. The company also has a net order book of S\$6.7 billion comprising rig building, ship conversion and offshore projects.
- Hyflux Ltd announced a 5% rise in 3Q09 net profit to S\$18.1 million from S\$17.3 million a year ago. Revenue fell 29% to S\$126.5 million from S\$177.4 million. The decrease came as the company was hit by a slowdown in the China market.
- Rotary Engineering Ltd reported net profit for the three months ended 30 September 2009 rose 11% to S\$10.73 million. Revenue for the third quarter slipped 8% to S\$108.78 million as several projects were completed and new projects have yet to generate significant revenue.

Local and Regional Markets Headline

Singapore shares closed 1.03 per cent higher on Wednesday ahead of a US Federal Reserve decision on interest rate policy, dealers said. The blue-chip Straits Times Index rose 27.09 points to 2,648.64. Volume traded totalled 1.13 billion shares worth \$999 million (US\$719 million).

Malaysian shares closed up 0.93 per cent on Wednesday with active buying interest in selected heavyweights, dealers said. The Kuala Lumpur Composite Index climbed 11.52 points to 1,253.84 on volume of 1.26 billion shares worth RM1.31 billion (US\$383.47 billion).

Hong Kong shares closed up 1.76 per cent on Wednesday on bargain-hunting following two days of declines. The benchmark Hang Seng Index gained 374.71 points to 21,614.77. Turnover was HK\$60.05 billion (US\$7.75 billion).

The Nikkei average rose 0.4 per cent on Wednesday, with Fast Retailing climbing on a surge in sales at its Uniqlo clothing stores but some exporters losing ground due to caution before a Federal Reserve statement on interest rates and the economy. The benchmark Nikkei added 41.36 points to 9,844.31, after sliding 2.3 per cent on Monday to hit a three-week closing low.

U.S. stocks mostly eked out a gain on Wednesday, giving back a big slice of the day's advance after the Federal Reserve reiterated its intent to keep rates low, but gave investors few new reasons to boost holdings. The Dow Jones industrial average gained 30.23 points, or 0.31 percent, to end at 9,802.14. The Standard & Poor's 500 Index .SPX edged up 1.09 points, or 0.10 percent, to 1,046.50. But the Nasdaq Composite Index dipped 1.80 points, or 0.09 percent, to close at 2,055.52.






