Technical

STI Facing Downside Risk

The odds in the equity market now are stacked in favour of the bears. The S&P 500 continues to show a divergence and the Dollar has spiked after rejecting strong support in the 74.50 to 74.00 region that we mentioned. There is also a divergence present in the STI. We continue to maintain the view that we will see weakness in the STI in the short term and advise investors to stay out of longs.

- CSC Holdings Limited wishes to announce that its wholly owned subsidiary, Kolette Pte Ltd has on 7 December 2009, entered into a sale and purchase agreement with Tat Hong Plant Leasing Pte Ltd to acquire approximately 6,200 square metres of vacant industrial land known as Lot 3610m of Mukim 7 for a cash consideration of approximately S\$2.8 million.
- Soilbuild Group Holdings Ltd has been appointed by Kolette Pte Ltd, a wholly-owned subsidiary of foundation and geotechnical engineering specialist CSC Holdings Limited, to manage the design development, construction and marketing of the S\$51.7 million project business space development at Tuas South Avenue 2.
- Asia Pacific Breweries Limited (APB) entered into agreements with Heineken International B.V. to:
 purchase Heineken's 68.5% interest in Indonesian-based PT Multi Bintang Indonesia Tbk (MBI);
 purchase Heineken's 87.3% interest in Grande Brasserie de Nouvelle Caledonie S.A. (GBNC) located
 in New Caledonia; and sell APB's wholly-owned Indian operations, Asia Pacific Breweries (Aurangabad)
 Private Limited and Asia Pacific Breweries-Pearl Private Limited to Heineken. APB will invest
 approximately \$\$484.4 million.
- Neptune Orient Lines Ltd reported for the four weeks of P11 (17 October 2009 to 13 November 2009 2009), container-shipping volumes increased 23% while average revenue per FEU (Forty-foot Equivalent Unit) declined 28% over the same period last year due to lower core freight rates and lower bunker recovery.
- Singapore Post Limited wishes to announce that Quantium Solutions International Pte Ltd, a wholly-owned subsidiary of SingPost, has incorporated a wholly-owned subsidiary in Taiwan by the name of "G3 Worldwide Mail (Taiwan) Co., Ltd". G3 Taiwan will engage in mail logistics, distribution and related services in Taiwan.
- First Ship Lease Trust said it has decided to not proceed with the plans to issue up to US\$200 million senior notes due 2016 due to the outbreak of the Dubai World credit crisis and this has affected investor sentiment, particularly in Asia and Europe.



- Novo Group Ltd announced that has achieved revenue of US\$114.2 million in 2Q2010 from US\$81.2 million in 2Q2009, representing an increase of 40.6%. Gross profit increased to US\$24.2 million in 2Q2010 from US\$5.0 million in 2Q2009 and gross profit margin rising from 6.2% in 2Q2009 to 21.2% in 2Q2010. Net profit of the Group during the period improved to US\$1.5 million from a loss of US\$3.6 million in the previous corresponding financial period (2Q2009).
- Pteris Global Limited is pleased to announce that it has received subscriptions for a total of 213. 5 million rights shares as at the close of the rights issue exercise on 3 December 2009. This represents an over subscription of approximately 160.42% of the total number of rights shares available under the rights issue.

Local and Regional Markets Headline

Singapore shares closed 0.21 per cent higher in lacklustre trade on Monday as the market wound down towards the end of the year, dealers said. The blue-chip Straits Times Index gained 5.97 points to 2,796.98 on volume of 1.27 billion shares worth \$1 billion (US\$721 million). Losers led gainers 231 to 205, with 808 issues unchanged.

Japan's Nikkei stock average climbed 1.5 per cent to a six-week closing high on Monday, with exporters boosted by the dollar's surge against the yen late last week after better-than-expected US jobs data fanned recovery hopes. The benchmark Nikkei rose 145.01 points to 10,167.60 and its highest close since late October, though at one point it had risen as much as 1.8 per cent. The broader Topix rose 1.1 per cent to 898.93.

Hong Kong stocks closed 0.77 per cent lower on Monday, as commodity issues fell after gold prices eased, while Geely Automobile climbed to a record high on an upbeat sales target. The benchmark Hang Seng Index ended down 173.19 points at 22,324.96.

Malaysian shares closed down 0.38 per cent on Monday, triggered by profit taking in late trading, dealers said. The Kuala Lumpur Composite Index lost 4.84 points to 1,265.36. Losers outpaced gainers 309 to 295.

US Market News

The S&P 500 and Nasdaq ended slightly lower on Monday and the Dow was flat, reversing earlier gains, after comments by Federal Reserve Chairman Ben Bernanke sparked jitters about the economic recovery. Speaking at the Economic Club of Washington, Bernanke said inflation could remain subdued, but the U.S. unemployment rate could remain elevated for some time.

The Dow Jones industrial average ended up 1.21 points, or 0.01 percent, at 10,390.11. The Standard & Poor's 500 Index lost 2.73 points, or 0.25 percent, at 1,103.25. The Nasdaq Composite Index fell 4.74 points, or 0.22 percent, at 2,189.61. Volume was light on the New York Stock Exchange, with 1.06 billion shares changing hands, below last year's estimated daily average of 1.49 billion, while on the Nasdaq, about 1.89 billion shares traded, also below last year's daily average of 2.28 billion.
