#### Local and Regional Markets Headline

Singapore shares closed 0.55 per cent lower on Thursday as traders stayed on the sidelines, dealers said. The blue-chip Straits Times Index fell 15.35 points to 2,781.86 on volume of 1.59 billion shares worth \$1.41 billion (US\$1.01 million). There were 193 gainers and 286 losers, with 772 issues unchanged.

Japan's Nikkei average fell 1.4 per cent on Thursday after a recent sharp rebound, as credit troubles overseas weighed on investor confidence and a stronger yen pressured shares of exporters. The benchmark Nikkei lost 141.90 points to 9,862.82, falling for a third day after having gained nearly 12 per cent in a six-day rally to Monday. The broader Topix retreated 1.3 per cent to 873.90.

Hong Kong shares finished 0.19 per cent lower on Thursday as Chinese property companies were weighed by Beijing's moves to rein in asset bubbles on the mainland. The benchmark Hang Seng Index dropped 41.72 points to 21,700.04. Turnover was HK\$82.03 billion (US\$10.60 billion)

Malaysian shares closed up 0.33 per cent on Thursday led by gains in construction and finance stocks, dealers said. The Kuala Lumpur Composite Index gained 4.14 points to 1,259.90. Losers outpaced gainers 335 to 278.

#### **US Market News**

US stocks gained on Thursday as signs of improving trends in the job market and a decline in the US October trade deficit reassured investors the economy was on a steady growth path.

The Dow Jones industrial average was up 68.78 points, or 0.67 per cent, at 10,405.83. The Standard & Poor's 500 Index ended up 6.40 points, or 0.58 per cent, at 1,102.35. The Nasdaq Composite Index closed up 7.13 points, or 0.33 per cent, at 2,190.86. Volume was light on the New York Stock Exchange (NYSE), with 1.06 billion shares changing hands, below last year's estimated daily average of 1.49 billion, while on the Nasdaq, about 1.96 billion shares traded, also below last year's daily average of 2.28 billion.
