Company Highlights

- Chartered Semiconductor Manufacturing Ltd announced that it has begun its next phase of expansion, equipment move-in, and installation for its most advanced manufacturing facility, Fab 7 a 300-millimeter (mm) wafer fab. The current expansion phase will ramp capacity for the company's manufacturing processes from about 30,000 wafers to almost 50,000 per month.
- **Singapore Technologies Engineering Ltd** announced that ST Electronics (Info-Security) Pte. Ltd. has acquired the remaining 38.88% equity stake in DataMark Technologies Pte Ltd from four of the existing shareholders for a total cash consideration of S\$148,000. Consequent to the purchase, DataMark will become a wholly-owned subsidiary of STEE-InfoSec.
- Chartered Semiconductor Manufacturing Ltd received two major awards in the "Small or Mid-Cap" category at the recent IR Magazine Southeast Asia Investor Relations Awards 2009. The company was named the Grand Prix winner for Best Overall Investor Relations while Lim Li Chuen, director of investor relations at Chartered, was named Best Investor Relations Professional.
- C&G Industrial Holdings Limited announced that it is entering into the environmental protection industry with RMB563.7 million acquisition of CUGU Environmental Protection International Limited, a leading developer and operator of waste-to-energy plants headquartered in Hong Kong, with the issuance of 505,023,354 new shares, priced at S\$0.24 per share.
- Noble Group announced a high-level restructuring of key positions that will take effect from 1 January 2010. The firm's founder and current CEO Richard Elman will become executive chairman and the current Chief Operating Officer, Mr. Ricardo Leiman will assume the post of Chief Executive Officer of the Group. Noble's non-executive chairman, David Eldon will remain on the board as a senior independent and non-executive director.
- Hong Leong Asia Ltd announced the incorporation of Y&C Engine Co., Ltd in the People's Republic
 of China. Y&C is a 45%-owned joint venture company of the Company, with the other joint venture
 parties Jirui United Heavy Industry Co., Ltd. and Shenzhen City Jiusi Investment Management Co., Ltd
 holding respectively 45% and 10% interest in Y&C. The registered capital of Y&C is RMB500 million.
- **Healthway Medical Corporation Limited** proposed to undertake a renounceable underwritten rights issue of up to 276,950,596 new ordinary shares at an issue price of \$\$0.075 for each Rights Share on the basis of one (1) Rights Share for every five (5) existing ordinary shares in the capital of the Company. The time and date of the Rights Issue is to be determined by the Directors. The net proceeds will amount to approximately \$\$19.8 million and will be used to invest in medical centres in China and in other general working capital purposes.
- **Enviro-Hub Holdings Ltd** announced the incorporation of Cimelia Canada Ltd by Cimelia Resource Recovery Pte Ltd, its wholly own subsidiary. Cimelia Canada Ltd recycles electronic wastes, refines platinum group metals, and also engages in general wholesale trade.



- **ISDN Holdings Limited** announced that the Company has incorporated a wholly owned subsidiary in Wujiang, China with a paid up capital of US\$100,000. The subsidiary will manage the ISDN Industrial High-Tech Industrial Park at Wujiang Economic Development Zone in Wujiang, China.
- CapitaLand Limited announced that its indirect wholly owned subsidiary, CapitaLand (China)
 Investment Co., Ltd. has increased its registered capital from US\$74.3 million to US\$101 million. The
 increase is by way of a cash injection by CapitaLand China Holdings Pte Ltd, another indirect whollyowned subsidiary of CapitaLand.
- CapitaLand Limited announced that its indirect wholly owned subsidiary, CapitaLand Management (China) Co., Ltd. has acquired 100% stake in Ningbo Jiangbei Kaide Property Service Co., Ltd. from Ningbo Xin Yin Property Development Co., Ltd. Following the Acquisition, Ningbo Jiangbei Kaide became an indirect wholly-owned subsidiary of CapitaLand. The cash consideration of the acquisition was RMB200,000.
- CapitaMalls Asia Limited announced that its indirect wholly-owned subsidiary, CapitaLand Retail
 Malaysia Sdn. Bhd. has increased its issued and paid-up share capital from RM2 to RM500,000.
 CRMSB has allotted and issued an additional 499,998 ordinary shares of RM1 each to its sole
 shareholder, CapitaLand Retail (MY) Pte. Ltd. for a cash consideration of RM499,998.
- China Yongsheng Limited announced that it has entered into a sale and purchase agreement with a
 third party for the disposal of 100% of the equity interest in a subsidiary, Changxing Yongye Quarry
 Co., Ltd. The consideration for the Disposal is RMB 23,278,110 and it will be paid within 120 days from
 the completion date of the sale and purchase agreement.

Local and Regional Markets Headline

Singapore shares closed flat on Thursday amid a pullback in other regional stock markets, dealers said. The blue-chip Straits Times Index eased 0.66 points, or 0.02 per cent, to 2,813.27 as momentum fizzled out after hitting a new high for the year. Volume was 1.40 billion shares worth \$1.34 billion (US\$957 million). Decliners outnumbered rising stocks 248 to 194, with 821 issues unchanged.

Hong Kong shares finished down 1.22 per cent on Thursday following losses on the mainland and on liquidity concerns amid capital outflows as the greenback strengthens. The benchmark Hang Seng Index shed 264.11 points to 21,347.63. Turnover was HK\$66.60 billion (US\$8.59 billion).

Japan's Nikkei average ended down 0.1 per cent on Thursday, slipping from seven-week highs hit earlier in the day, as investors pocketed profits on a rally in big banks such as Mitsubishi UFJ Financial Group. The benchmark Nikkei inched down 13.61 points to 10,163.80, after earlier rising as high as 10,260.12, its highest level since Oct 27. The broader Topix edged down 0.2 per cent at 896.28.

Malaysian shares closed down 0.16 per cent on Thursday ahead of a long weekend, with the market closed on Friday for a public holiday, dealers said. The Kuala Lumpur Composite Index lost 2.06 points to 1,266.97. Losers outnumbered gainers 316 to 284.

US Market News

US stocks fell on Thursday as the dollar's rebound spurred a safe-haven trade, cutting demand for riskier assets, while a soft profit outlook from economic bellwether FedEx sank transportation shares. The Dow Jones industrial average dropped 132.86 points, or 1.27 per cent, to end at 10,308.26. The Standard & Poor's 500 Index fell 13.10 points, or 1.18 per cent, to 1,096.08. The Nasdaq Composite Index lost 26.86 points, or 1.22 per cent, to close at 2.180.05.

Volume was above average on the New York Stock Exchange, with 1.72 billion shares changing hands, well above last year's estimated daily average of 1.49 billion, while on the Nasdag, about 1.94 billion shares traded, below last



year's daily average of 2.28 billion.

Declining stocks outnumbered advancing ones on the NYSE by a ratio of about 11 to 4, while on the Nasdaq, about 20 stocks fell for every seven that rose.
