

PhillipMart Announces Pre-IPO Share Price of AIA Group Limited (Stock code: 01299)

(Hong Kong – 28Oct 2010) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **AIA Group Limited** ("AIA"; stock code: 01299) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for AIA on PhillipMart were HK\$21.70 and HK\$20.60. The price closed at HK\$21.60 per share, 9.76% higher than its offer price of HK\$19.68. The price opened at HK\$21.00, with the most actively traded price of HK\$21.40 per share, and a turnover of 3,851,200shares. The total trading volume reached 10,928,000shares with total turnover of HK\$234,204,390.00(The highest turnover record in PhillipMart). The final price of AIA, to debut trading tomorrow has been fixed at HK\$19.68 per share.
