

**PhillipMart Announces Pre-IPO Share Price of  
 Evergreen International Holdings Limited (Stock code: 00238)**

(Hong Kong – 3 Nov 2010) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of **Evergreen International Holdings Limited** (“Evergreen”; stock code: 00238) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Evergreen on PhillipMart were HK\$6.50 and HK\$6.15. The price closed at HK\$6.40 per share, 39.13% higher than its offer price of HK\$4.60. The price opened at HK\$6.20, with the most actively traded price of HK\$6.26 per share, and a turnover of 1,102,000shares. The total trading volume reached 9,723,000shares with total turnover of HK\$61,227,950.00. The final price of Evergreen, to debut trading tomorrow has been fixed at HK\$4.60 per share.
