

PhillipMart Announces Pre-IPO Share Price of China Tian Lun Gas Holdings Limited (Stock code: 01600)

(Hong Kong – 09 Nov 2010) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **China Tian Lun Gas Holdings Limited** ("Tian lun"; stock code: 01600) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Tian lun on PhillipMart were HK\$2.35 and HK\$2.10. The price closed at HK\$2.12 per share, 3.41% higher than its offer price of HK\$2.05. The price opened at HK\$2.30, with the most actively traded price of HK\$2.15 per share, and a turnover of 970,500 shares. The total trading volume reached 7,068,000 shares with total turnover of HK\$15,353,685. The final price of Tian lun, to debut trading tomorrow has been fixed at HK\$2.05 per share.
