

**PhillipMart Announces Pre-IPO Share Price of  
 CITIC Dameng Holdings Limited (Stock code: 01091)**

(Hong Kong – 17 Nov 2010) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of **CITIC Dameng Holdings Limited** (“**CITIC Dameng**”; stock code: 01091) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for CITIC Dameng on PhillipMart were HK\$2.68 and HK\$2.36. The price closed at HK\$2.61 per share, -5.08% lower than its offer price of HK\$2.75. The price opened at HK\$2.40, with the most actively traded price of HK\$2.63 per share, and a turnover of 1,074,000shares. The total trading volume reached 6,878,000shares with total turnover of HK\$17,781,250.00. The final price of CITIC Dameng, to debut trading tomorrow has been fixed at HK\$2.75 per share.
