

PhillipMart Announces Pre-IPO Share Price of China Rongsheng Heavy Industries Group Holdings Limited (Stock code: 01101)

(Hong Kong – 18 Nov 2010) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **China Rongsheng Heavy Industries Group Holdings Limited** ("Rongsheng"; stock code: 01101) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Rongsheng on PhillipMart were HK\$8.54 and HK\$7.7. The price closed at HK\$8.54 per share, 6.75% higher than its offer price of HK\$8.00. The price opened at HK\$8.19, with the most actively traded price of HK\$8.30 per share, and a turnover of 3,000,000shares. The total trading volume reached 13,300,500shares with total turnover of HK\$109,629,190.00. The final price of Rongsheng, to debut trading tomorrow has been fixed at HK\$8.00 per share.
