## PhillipMart Announces Pre-IPO Share Price of China Modern Dairy Holdings Ltd. (Stock code: 01117)

(Hong Kong – 25 Nov 2010) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **China Modern Dairy Holdings Ltd.** ("Modern Dairy"; stock code: 01117) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Modern Dairy on PhillipMart were HK\$2.80 and HK\$2.71. The price closed at HK\$2.79 per share, -3.45% lower than its offer price of HK\$2.89. The price opened at HK\$2.80, with the most actively traded price of HK\$2.75 per share, and a turnover of 162,000shares.
