

## PhillipMart Announces Pre-IPO Share Price of Sateri Holdings Limited (Stock code: 01768)

(Hong Kong – 7Dec 2010) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **Sateri Holdings Limited** ("Sateri"; stock code: 01768) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Sateri on PhillipMart were HK\$6.65 and HK\$6.50. The price closed at HK\$6.65 per share, 0.76% higher than its offer price of HK\$6.60.
