PhillipMart Announces Pre-IPO Share Price of Greatview Aseptic Packaging Company Limited (Stock code: 00468)

(Hong Kong – 08 Dec 2010) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **Greatview Aseptic Packaging Company Limited** ("Greatview Aseptic Packaging"; stock code: 00468) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Greatview Aseptic Packaging on PhillipMart were HK\$4.51 and HK\$4.36. The price closed at HK\$4.40 per share, 2.33% higher than its offer price of HK\$4.30.
