

PhillipMart Announces Pre-IPO Share Price of MIE Holdings Corporation (Stock code: 01555)

(Hong Kong – 13 Dec 2010) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **MIE Holdings Corporation** ("MIE Holdings"; stock code: 01555) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for MIE Holdings on PhillipMart were HK\$1.80 and HK\$1.73. The price closed at HK\$1.75 per share, 2.94% higher than its offer price of HK\$1.70. The price opened at HK\$1.80, with the most actively traded price of HK\$1.76 per share, and a turnover of 650,000shares. The total trading volume reached 2,100,000shares with total turnover of HK\$3,679,120.00. The final price of MIE Holdings, to debut trading tomorrow has been fixed at HK\$1.70 per share.
