

## PhillipMart Announces Pre-IPO Share Price of World Wide Touch Technology Holdings Limited (Stock code: 01282)

Pre-IPO highest and lowest trading prices for **World Wide Touch Technology** on PhillipMart were HK\$1.04 and HK\$0.97.
