

**PhillipMart Announces Pre-IPO Share Price of
 Biostime International Holdings Limited (Stock code: 01112)**

(Hong Kong – 16 Dec 2010) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of **Biostime International Holdings Limited** (“Biostime”; stock code: 01112) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Biostime on PhillipMart were HK\$11.20 and HK\$10.94. The price closed at HK\$11.08 per share, 0.73% higher than its offer price of HK\$11.00.
