## PhillipMart Announces Pre-IPO Share Price of China Datang Corporation Renewable Power Co., Limited(Stock code: 01798)

(Hong Kong – 16 Dec 2010) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **China Datang Corporation Renewable Power Co., Limited** ("Datang Renewable Power"; stock code: 01798) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Datang Renewable Power on PhillipMart were HK\$2.30 and HK\$2.30. The price closed at HK\$2.30 per share, -1.28% lower than its offer price of HK\$2.33.
