

## PhillipMart Announces Pre-IPO Share Price of Hengxin Technology Ltd. (Stock code: 01085)

(Hong Kong – 22 Dec 2010) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **Hengxin Technology Ltd.** ("Hengxin Technology"; stock code: 01085) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Hengxin Technology on PhillipMart were HK\$2.48 and HK\$2.25. The price closed at HK\$2.32 per share, 3.11% higher than its offer price of HK\$2.25. The price opened at HK\$2.48, with the most actively traded price of HK\$2.33 per share, and a turnover of 100,000 shares. The total trading volume reached 498,000 shares with total turnover of HK\$1,154,200. The final price of Hengxin Technology, to debut trading tomorrow has been fixed at HK\$2.25 per share.
