

## PhillipMart Announces Pre-IPO Share Price of

Changsha Zoomlion Heavy Industry Science and Technology Development Co., Ltd. (Stock code: 01157)

(Hong Kong – 22 Dec 2010) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **Changsha Zoomlion Heavy Industry Science and Technology Development Co., Ltd.** ("Zoomlion"; stock code: 01157) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Zoomlion on PhillipMart were HK\$15.40 and HK\$15.18. The price closed at HK\$15.20 per share, 1.47% higher than its offer price of HK\$14.98. The price opened at HK\$15.40, with the most actively traded price of HK\$15.20 per share, and a turnover of 169,600shares. The total trading volume reached 377,600shares with total turnover of HK\$5,767,180.00. The final price of Zoomlion, to debut trading tomorrow has been fixed at HK\$14.98 per share.
