

**PhillipMart Announces Pre-IPO Share Price of  
 Sumpo Food Holdings Limited (Stock code: 01089)**

(Hong Kong – 10 JAN 2011) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of Sumpo Food Holdings Limited (“Sumpo Food”; stock code: 01089) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Sumpo Food on PhillipMart were HK\$0.76 and HK\$0.71. The price closed at HK\$0.76 per share, 11.76% higher than its offer price of HK\$0.68. The price opened at HK\$0.72, with the most actively traded price of HK\$0.75 per share, and a turnover of 2,870,000 shares. The total trading volume reached 8,195,000 shares with total turnover of HK\$6,051,400. The final price of Sumpo Food, to debut trading tomorrow has been fixed at HK\$0.68 per share.
