

**PhillipMart Announces Pre-IPO Share Price of
 Newtree Group Holdings Limited (Stock code: 01323)**

(Hong Kong – 12Jan 2011) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of **Newtree Group Holdings Limited** (“Newtree Group holdings Limited”; stock code: 01323) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Newtree Group on PhillipMart were HK\$2.08 and HK\$1.94. The price closed at HK\$1.96 per share, 0.51% higher than its offer price of HK\$1.95. The price opened at HK\$2.08, with the most actively traded price of HK\$1.99 per share, and a turnover of 1,304,000shares. The total trading volume reached 4,358,000shares with total turnover of HK\$8,644,580.00. The final price of Newtree Group, to debut trading tomorrow has been fixed at HK\$1.95 per share.
