PhillipMart Announces Pre-IPO Share Price of Telefield International (Holdings) Limited (Stock code: 01143)

(Hong Kong – 26 Jan 2011) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **Telefield International (Holdings) Limited** ("Telefield"; stock code: 01143) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Telefield on PhillipMart were HK\$1.30 and HK\$1.22. The price closed at HK\$1.23 per share, 2.5% higher than its offer price of HK\$1.20. The price opened at HK\$1.30, with the most actively traded price of HK\$1.25 per share, and a turnover of 932,000shares. The total trading volume reached 2,822,000shares with total turnover of HK\$3,511,300.00. The final price of Telefield, to debut trading tomorrow has been fixed at HK\$1.20 per share.
