## PhillipMart Announces Pre-IPO Share Price of China Kingstone Mining Holdings Limited (Stock code: 01380)

(Hong Kong – 17 Mar 2011) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **China Kingstone Mining Holdings Limited** ("Chi Kingstone"; stock code: 01380) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Chi Kingstone on PhillipMart were HK\$2.25 and HK\$2.04. The price closed at HK\$2.24 per share, 0.43% lower than its offer price of HK\$2.25.
