## PhillipMart Announces Pre-IPO Share Price of China Hongqiao Group Limited (Stock code: 01378)

(Hong Kong – 23 March 2011) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **China Hongqiao Group Limited** ("China Hongqiao"; stock code: 01378) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for China Hongqiao on PhillipMart were HK\$7.19 and HK\$7.18 The price closed at HK\$7.18 per share, 0.27% lower than its offer price of HK\$7.20.
