PhillipMart Announces Pre-IPO Share Price of Far East Horizon Limited (Stock code: 03360)

(Hong Kong – 29 March 2011) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **Far East Horizon Limited** ("FE Horizon"; stock code: 03360) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **FE Horizon** on PhillipMart were HK\$6.95 and HK\$6.40. The price closed at HK\$6.90 per share, 9.7% higher than its offer price of HK\$6.29. The price opened at HK\$6.40, with the most actively traded price of HK\$6.90 per share, and a turnover of 1,846,000shares. The total trading volume reached 3,839,000shares with total turnover of HK\$26,358,820.00. The final price of FE Horizon, to debut trading tomorrow has been fixed at HK\$6.29 per share.
