

**PhillipMart Announces Pre-IPO Share Price of
 China NT Pharma Group Company Limited (Stock code: 01011)**

(Hong Kong – 19 April 2011) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of **China NT Pharma Group Company Limited** (“NT Pharma”; stock code: 01011) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for NT Pharma on PhillipMart were HK\$4.62 and HK\$4.40. The price closed at HK\$4.48 per share, 1.31% lower than its offer price of HK\$4.54. The price opened at HK\$4.59, with the most actively traded price of HK\$4.59 per share, and a turnover of 183,000shares. The total trading volume reached 975,500shares with total turnover of HK\$4,414,565.00. The final price of NT Pharma, to debut trading tomorrow has been fixed at HK\$4.54 per share.
