

## PhillipMart Announces Pre-IPO Share Price of Hilong Holding Limited (Stock code: 01623)

(Hong Kong – 20April 2011) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **Hilong Holding Limited** ("Hilong"; stock code: 01623) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Hilong on PhillipMart were HK\$2.65 and HK\$2.41. The price closed at HK\$2.55 per share, 1.91% lower than its offer price of HK\$2.60. The price opened at HK\$2.65, with the most actively traded price of HK\$2.60 per share, and a turnover of 167,000shares. The total trading volume reached 542,000shares with total turnover of HK\$1,395,450.00. The final price of Hilong, to debut trading tomorrow has been fixed at HK\$2.60 per share.
