

**PhillipMart Announces Pre-IPO Share Price of
 Billion Industrial Holdings Limited (Stock code: 02299)**

(Hong Kong – 17 May 2011) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of **Billion Industrial Holdings Limited** (“Billion Industrial”; stock code: 02299) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Billion Industrial on PhillipMart were HK\$5.70 and HK\$5.30. The price closed at HK\$5.31 per share, 2.51% higher than its offer price of HK\$5.18. The price opened at HK\$5.30, with the most actively traded price of HK\$5.70 per share, and a turnover of 435,500shares. The total trading volume reached 564,000shares with total turnover of HK\$3,180,065.00. The final price of Billion Industrial, to debut trading tomorrow has been fixed at HK\$5.18 per share.
