

## PhillipMart Announces Pre-IPO Share Price of China Flooring Holding Company Limited (Stock code: 02083)

(Hong Kong – 25 May 2011) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **China Flooring Holding Company Limited** ("China Flooring"; stock code: 02083) on PhillipMart, an automated electronic platform for pre-IPO shares trading.
