

**PhillipMart Announces Pre-IPO Share Price of
 Zhengye International Holdings Company Limited (Stock code: 03363)**

(Hong Kong – 2 June 2011) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of **Zhengye International Holdings Company Limited** (“Zhengye”; stock code: 03363) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **Zhengye** on PhillipMart were HK\$ 1.59 and HK\$1.52. The price closed at HK\$1.57 per share, 9.79% higher than its offer price of HK\$1.43. The price opened at HK\$1.55, with the most actively traded price of HK\$1.57 per share, and a turnover of 2,142,000 shares. The total trading volume reached 5,340,000 shares with total turnover of HK\$8,322,700.00. The final price of **Zhengye**, to debut trading tomorrow has been fixed at HK\$1.43 per share.
