

**PhillipMart Announces Pre-IPO Share Price of
 Dragon Crown Group Holdings Limited (Stock code: 00935)**

(Hong Kong – 9 June 2011) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of **Dragon Crown Group Holdings Limited** (“Dragon Crown”; stock code: 00935) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **Dragon Crown** on PhillipMart were HK\$1.13 and HK\$1.04. The price closed at HK\$1.12 per share, 1.82% higher than its offer price of HK\$1.10. The price opened at HK\$1.12, with the most actively traded price of HK\$1.12 per share, and a turnover of 1,638,000shares. The total trading volume reached 4,102,000shares with total turnover of HK\$4,538,720.00. The final price of **Dragon Crown**, to debut trading tomorrow has been fixed at HK\$1.10 per share.
