

PhillipMart Announces Pre-IPO Share Price of Huaneng Renewables Corporation Limited (Stock code: 00958)

(Hong Kong – 9 June 2011) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **Huaneng Renewables Corporation Limited** ("Huaneng Renewables"; stock code: 00958) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **Huaneng Renewables** on PhillipMart were HK\$2.52 and HK\$2.29. The price closed at HK\$2.52 per share, 0.80% higher than its offer price of HK\$2.50. The price opened at HK\$2.40, with the most actively traded price of HK\$2.50 per share, and a turnover of 1,052,000 shares. The total trading volume reached 5,872,000 shares with total turnover of HK\$14,117,280.00. The final price of **Huaneng Renewables**, to debut trading tomorrow has been fixed at HK\$2.50 per share.
