

PhillipMart Announces Pre-IPO Share Price of Samsonite International S.A (Stock code: 01910)

(Hong Kong – 15 June 2011) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **Samsonite International S.A** ("Samsonite"; stock code: 01910) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **Samsonite** on PhillipMart were HK\$14.00 and HK\$13.70. The price closed at HK\$13.96 per share, 3.71% lower than its offer price of HK\$14.50. The price opened at HK\$13.80, with the most actively traded price of HK\$13.84 per share, and a turnover of 66,000shares. The total trading volume reached 128,700shares with total turnover of HK\$1,778,370.00. The final price of **Samsonite**, to debut trading tomorrow has been fixed at HK\$14.50 per share.
