PhillipMart Announces Pre-IPO Share Price of Modern Education Group Limited (Stock code: 01082)

(Hong Kong – 30 Jun 2011) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **Modern Education Group Limited** ("Modern Education"; stock code: 01082) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **Modern Education** on PhillipMart were HK\$1.62 and HK\$1.46. The price closed at HK\$1.60 per share, 23.08% higher than its offer price of HK\$1.30. The price opened at HK\$1.50, with the most actively traded price of HK\$1.60 per share, and a turnover of 300,800 shares. The total trading volume reached 514,000 shares with total turnover of HK\$809,480. The final price of **Modern Education**, to debut trading tomorrow has been fixed at HK\$1.30 per share.
