

## PhillipMart Announces Pre-IPO Share Price of Newton Resources Limited (Stock code: 01231)

(Hong Kong – 30 Jun 2011) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **Newton Resources Limited** ("Newton Resources"; stock code: 01231) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **Newton Resources** on PhillipMart were HK\$1.93 and HK\$1.80. The price closed at HK\$1.92 per share, 9.71% higher than its offer price of HK\$1.75. The price opened at HK\$1.80, with the most actively traded price of HK\$1.92 per share, and a turnover of 1,390,000 shares. The total trading volume reached 2,022,000 shares with total turnover of HK\$3,863,520.00. The final price of **Newton Resources**, to debut trading tomorrow has been fixed at HK\$1.75 per share.
