

**PhillipMart Announces Pre-IPO Share Price of
 China Print Power Group Limited (Stock code: 06828)**

(Hong Kong – 11 July 2011) Phillip Securities (HK) Ltd. (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of China Print Power Group Limited (“China Print Power”; stock code: 06828) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **China Print Power** on PhillipMart were HK\$1.59 and HK\$1.48. The price closed at HK\$1.59 per share, 7.43% higher than its offer price of HK\$1.48. The price opened at HK\$1.49, with the most actively traded price of HK\$1.58 per share, and a turnover of 1,136,000shares.
